

Historic Woodward Inn Destroyed By Fire

Firefighters were dispatched early Sunday morning, October 5, 2025 to the historic Woodward Inn on Route 45 in Woodward, shortly after 2:30 am. Upon arriving at the scene, it was reported that flames were shooting out of the roof of the structure. According to Millheim Fire Chief Delmer Homan, despite firefighters' efforts contain the massive blaze, the fire spread throughout the original stone building and into a newer addition. The fire started at the rear of the building. Then it moved into the original inn. Due to the size of the three-story structure and rapidly spreading fire, the scene was upgraded to a third

alarm. Additional manpower arrived from fire departments from Centre, Union, and Clinton Counties.

Mifflinburg Hose Company was one of the departments called to the scene for mutual aid. Shortly after 2:30 am, MHC was dispatched to the Woodward Inn in Centre County. According to MHC Fire Chief Steve Walter, "There was heavy fire when we arrived. Tower, 2 Engines and Rescue were working on scene. We helped with fire suppression and overhaul. We were on scene for about 4.5 hours."

Mifflinburg Hose Company's Tower 3 setup for aerial operations. Engine and Rescue 3 crews assisted in fire suppression and overhaul efforts. This is one of the first working fires that MHC had the opportunity to use their new aerial. Engine 3 also shuttled water in the tanker shuttle.

No injuries were reported. One firefighter fell through the floor but was not hurt.

The was not occupied at the time of the fires. The owners, Mr. and Mrs. Corby Stover were in the final stages of refurbishing the Woodward Inn. They were planning to reopen it as a B&B in the town. A post on Facebook stated, "They bought this piece of Woodward history 2 years ago and have been pouring their heart and soul into renovating it. For reasons unknown at this time, it was destroyed by fire last night. However, the 200 year old stone walls refused to go down. Here's hoping this beautiful building can somehow be returned to its former glory."

The fire was investigated by a state fire marshal.

The blaze destroyed the historic 1814 inn and tavern that was in the process of being restored. Known as the Stagecoach Inn, the Woodward Inn is a stone building with a frame extension built along the back of the structure. The Stagecoach Inn was an overnight stopping place for travelers. In 1845, it was renamed after George Woodward, a candidate for governor of Pennsylvania. In 1978, the Woodward Inn was recorded in the National Register of Historic Places. It was declared a total loss after the fire.

It all started on Friday when a field of 56 drivers signed up for the first of two nights of racing, it was the 39th year for the national Open at Williams Grove. It started with World of Outlaw driver Carson Macedo setting fast time of 16.409 seconds. Before the feature action Gravel buddy Kofoid two WOO series, driver Lance Dewease Pa Posse member and Daison Pursley a High Limit series regular won the heat races with Sheldon Haudenschild winning the B-main Kyle Spence won the C-main with Ryan newton claiming the non-qualifiers race. Carson Macedo led the first 20-laps before PA Posse driver Chase Dietz bolted into the lead. Dietz went on to score his fifth Williams Grove feature win, but it was a first for his car owner John Stehman, Lance Deweas placed second with Danny Dietrich getting by Macedo on the last laps to have a podium sweep for the Pa Posse drivers. Macedo was fourth with another Posse driver Justin Whittall fifth. Saturday night was the 63rd running of the National Open event with another field of 56 drivers on hand. Again, David Gravel set fast time with a clocking of 16.687 seconds off f the track record which is owned

by TJ Stuttz with a time of 16.003. Heats went to three Outlaws drivers Gravel Macedo, Bill Balog and Dyran Pittman who was driving the local Kreitz #69K. Lance Dewease won the B-main with TJ Stuttz winning the C-Main Donny Schatz won the non-qualifiers race and made it into the big show starting 27th in the feature for the ten-time WOO series champion. Bill Balog led the field to the green flag for the 40-lap feature, the original driver from Alaska now living in the state of Wisconsin. Balog was setting a torrid pace for the first part of the race. A yellow on lap 14th turned into a fuel stop for the 410-sprint, but after the green fell again Balog was up to the challenges of Sheldon Haudenschild who found speed after the red flag and was challenge for the led which he final took over for good with one lap to go, with Danny Dietrich also slipping Balog on the final lap with Balog third, with Daryn Pittman fourth and Buddy Kofoid fifth. Dietrich noted about his second-place finish that if he had one more lap, he believed he could have won the race which pays winner Haudenschild \$75,000. Troy Wagaman Jr with his 20th place finish won the Williams Grove track title with his nearest challenge Freddie Rahmer placing 27th. It was a career first title for Wagaman and for car owner Mike Heffner it was his fifth title, four of them were with the late Greg Hodnett. Williams Grove has announced their opening date for the 2026 season will be Sunday March 22nd starting at 2pm. Other announcements from the Grove Preston Lattomus were named the tracks rookie of the year with Cameron Smith getting the most improved driver award, with Track champion Troy Wagaman Jr crew Chief getting the Dave Brown Sr Mechanic of the year award.

Sad note from the weekend when it was announced of the passing of Hall of Fame driver from Hanover Pa had passed away on Sunday at the ago of 81. Allen was just at the Grove on Saturday night to watch his driver Logan Schuhart placed seventh with his Jacob Allen owned with driver Ashton Torgerson did not qualify. Allen has 36 career wins at Williams Grove and was early in his career known as the original traveling all of the county to go racing for bigger purses where he could find them. Bobby relocated from the state of Florida back in the 60's and made acer of racing not only in central Pa but all over the county until retire from racing. After that he fielded cars for his grandson Logan Schurhart and Jacob Allen to form Shark racing Bobby Allen scored his biggest win during the 1990 Knoxville National when he drove his self-owned car to the big victory Nick named Scruffy early in in his career for is looks, but did thing his own way building his own cars and beating a number of top teams over his career, Allen who his first Grove feature back in the 1969 season, he won the national open in the 1975 season when the race was run for 150-laps..

This Friday night is the final race of the season for Selinsgrove speedway with the 410-sprint and the 360/358 sprint car challenge are both races are to honor the late Kramer Williamson, the 410's will be racing for \$7,300 to win the 360/358 racing for \$2,073 to win. Another Selinsgrove news is that the Speedway Management team of Jenna Mowery, Paula Schick and Colin Rice have signed an agreement with the Selinsgrove Fair board to run the speedway again in the 2026 racing season. Track

champions for this season have been for the super late models Rick Eckert of York, Lane Snook of Mifflin PA the limited late model champion Jason Geesaman is the street stock champion and Kruz Kepner of Kreamer PA. The Pass 305-sprint champion, Kepner is also the PASS series champion. This Friday the point championship for the 410-sprint will be decided between Danny Dietrich who holds a 230 point lead over Blane Heimbach, it would be a first for Danny Dietrich to win a Selinsgrove title Blane has won them before in the in the 358 sprint car which was a regular division in the early 2000 seasons Blane won three title 2005, 2006 and 2011 before h move over to race in the 410sprints.

Lots of racing left this month, this Saturday the WOO sprint car series will be racing at Lincoln Speedway the second time this season with Buddy Kofoid winning the race back in May over Chase Dietz, Anthony Macri, David Gravel and Sheldon Haudenschild, a four-cylinder class will also be racing with the sprints at Lincoln. BAPS motor speedway will be holding the 22nd annual Fall Nationals which will have a number of different divisions in action over two days on Friday and Saturday. The PASS 305-sprint will race on Friday night. Limited late models Super Sportsman, Legends car, Extreme stocks and Classic cars will be racing on Saturday. A total of seven different divisions will be in action over the two-day show. Greenwood Valley Action Track will be in action with a regular show of go-karts and micro-sprints this Saturday.

Scouts Participate in Homelessness Awareness Camp to Benefit HUB Missions

On October 17-18, 2025, Samuel Hostler will be holding an event in conjunction with his Eagle Scout Project. This event will be held at the Square in Middleburg across from the Courthouse. He, and the others who join him, will be camping out at the parking lot beginning at 6 pm on the 17th until 4 pm on the 18th. This event will help to bring awareness to the homelessness situation in Pennsylvania.

Samuel's Project is to benefit HUB Missions, an organization that serves the homeless community in Harrisburg. They travel from Middleburg to Harrisburg to provide needed supplies and help to these individuals who have fallen into hard times. They have been serving the community since 2020 when COVID shut down a lot of the volunteer groups that were operating in Harrisburg. Our capital city is a travel hub for those who are homeless. There are people from all over the United States who filter through central Pennsylvania.

According to the 2024 Annual Homelessness Assessment Report (AHAR) from the U.S. Department of Housing and Urban Development (HUD), on any given day there are over 14,000 people who are experiencing homelessness in Pennsylvania, a 12% increase from 2023. This total includes 4,564 people in families with children, 690 unaccompanied youth and 719 veterans.

It is a common misconception that these people are lazy or inferior in some way, which is untrue. One of the stories that HUB encountered was a gentleman on their first visit to Harrisburg. It was raining heavily so not many people came out to meet them. This man was in his truck in a parking lot next to HUB's vehicle. He had been married, had a two-story house with a pool in a nice development. His wife was a nurse, and he was in construction. She went to a doctor's appointment and was diagnosed with a very aggressive cancer. She died within 3 months of diagnosis. His wife took care of their finances and with her gone, he struggled to maintain what they had. He ended up losing everything but the truck that he was sleeping in. HUB was able to give him some jeans so that he had some work clothes. He was trying, just going through a rough patch. The realization that we are all just one phone call away from being homeless really impacted the people who were serving that night.

Samuel served with HUB as often as his schedule al-

lowed for several years, developing a heart for these people and their stories. His goal with his Eagle Scout Project is to purchase 100 duffel bags and fill these bags with items that are useful and helpful to someone experiencing homelessness. The purpose of this event that he is holding is to spread awareness of the homelessness situation and to collect items that will be packaged in the duffel bags and then delivered to HUB to help them in their mission to serve.

If anyone is interested in helping Samuel to complete his Eagle Scout Project, they can drive by on October 17 (after 6 pm) -October 18 (until 4 pm) and drop off items at the Square in Middleburg. The items being collected are: Throw Blankets, Smaller First Aid Kits, New Beanies, Razors, Deodorant, Feminine Products, Toilet Paper, Batteries (AAA, and AA), Portable Chargers, New Socks, Tooth Paste/Brushes, Floss, Baby Wipes, Hand Warmers, and \$5 Dunkin Donut Giftcards. 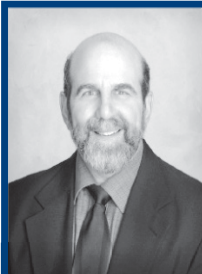

Our local field hockey teams are getting into playoff mode in what should be an exciting post- season. The district favorite looks to be Selingsgrove (14-2) as they one-upped Mifflinburg (11-3) with a Nora Moyer penalty goal in the fourth quarter. Bella Ferguson had 10 saves for the shutout. Senior night for the Seals saw three Seniors scoring three goals to beat Shik 3-0.

Lewisburg (9-3-1) took care of Shik 3-1 with Elliana Rupert's two goals being the difference. Tia Berge's two goals assisted by Julia Opperman was more than enough in beating Danville 4-0. No goals were scored when Line Mountain came to Lewisburg in a 0-0 draw.

Midd-West tied Northwest Area 2-2 and shutout Danville 7-0 as the Mustangs three top scorers for the year led the way. Maesyn Franquet had a goal and three assists, Audrey Resseguie two goals and three assists and Kylie Brown had a hat trick. Midd-West fell 5-0 to Line Mountain.

Miff beat Southern Columbia 4-1 with two goals from Kira Shoemaker who also had two goals and an assist in a 4-0 win over Muncy. Maize Sauder chipped in with a goal and assist. The biggest win was 1-0 over Midd-West on Lainey Miller's goal.

Mifflinburg's golf team was unable to defend their 2A district golf title as they were upset by four strokes by Towanda. You can't blame the Cats Wilson Abram who led all golfers in the district with a three under par 69. Selingsgrove finished third in 3A, 21 strokes behind Jersey Shore.

Mifflinburg's girls tennis team finished their season by losing to Loyalsock. These girls should be commended because they showed up ready to play in every match. The future looks bright for Mifflinburg tennis. Well done ladies.

Over on the Pitch the Grove girls continue to roll with a good showing in a 4-2 loss to undefeated Shik. Madi Merrell had a goal and assist. Miff led Selingsgrove (11-2) at halftime on two Ava LeMay goals but Merrell scored twice in the second half to prevent the upset in the 4-2 win. Addison Wenzel got her 50th career goal in a 13-0 rout of Williams Valley. Merrell had four goals and an assist. Courtney Smith contributed 2 goals and 3 assists.

Midd-West (7-4-1) beat Jersey Shore 2-0. The Mustangs are getting hot at the right time winning 5 of their last 6 games. Addison Yerg and Maci Tittle had the goals. Lewisburg (4-9-1) lost 6-2 to Milton despite goals from Ava Satteson and Adelynn Barner.

Speaking of rolling and staying hot the boys soccer team at Lewisburg (15-0-1) had three wins last week. 5-0 over Cedar Cliff on two Keegan Crosby goals. 9-0 win

over Williamsport on Isaac Ayres 3 goals and one assist and a 5-1 win over Danville.

The Green Dragons Viktor Permyashkin became only the second ever 50/50 soccer player in the rich history of Lewisburg soccer with at least 50 goals and 50 assists in his career.

Grove (6-6-1) beat Jersey Shore 2-0 on goals from Nick Bisaccia and Gabe Heimbach. Mifflinburg (6-9-1) is finding the net in bunches as the season is coming to a close. In a 7-1 win over Shamokin Warrick Beachy and Dylan Seigel combined for five goals and two assists. Freshman Coy Gemberling had the game winning goal. In an 8-2 W over Bloom, Seigel had four assists and two goals with Gemberling adding a goal and two assists. Goals were harder to come by in a 4-1 L to Danville.

I cannot wait for the district rematch of Midd-West vs Lewisburg. It was a Sellers night as Abram and Jacob Sellers scored goals in a 4-0 shutout of Williamsport. Layden Swinehart and Gabe Romig also scored. In another shutout which happens often with Derek Wert in goal, Midd-West beat Grove 2-0 with Romig involved with both goals.

Another tough week on the gridiron as the only win was one of our schools over another. Lewisburg (2-5) celebrated their homecoming game in Middleburg and defeated their gracious hosts 35-7.

Jaylen "Air" Walker got back to his early season form with 5 catches for 153 yards and 3 TD's from QB Xavier Carter. Nick Coleman averaged over 10 yards a carry on 7 rushes and one TD. Keaton Kreider got Midd-West on the board with a rushing touchdown. The Green Dragons face a tough three game stretch to end their season starting with Shamokin Friday night. Midd-West will host Milton Friday night.

Selingsgrove (1-6) lost to Shik for the first time since 2017. Shik jumped out to a 34-0 lead until Grove's highlight was a 65 yard TD scamper by Brett Rice. It doesn't get any easier for the Seals as Hollidaysburg comes calling after manhandling a really good Jersey Shore team last week 52-7.

Mifflinburg's season has hit a bit of a speed-bump in losing to Southern Columbia 21-14 in a game that could have gone either way. The Tigers ground game, 265 yards and pressure on the QB, six sacks were too much to overcome.

Chad Martin threw for 235 yards with Cole Reibsome hauling in a 30 yard TD and Seth Hartman ran for a 27 yard score. Mifflinburg has too many great athletes as receivers and need to get them out in space more so the sideline doesn't become a second defender. Miff travels to Central Columbia on Friday.

I am so glad my enjoyment of college football is not based on whether or not Penn

State wins. As a fan you want The Lions to do well but there are so many story lines every year, good and bad.

Watching the service academies play each other in college football always leaves you feeling a little bit better about our country. Navy/Air Force was a great game to watch. The real goosebumps come after the game when each academy sings their Alma Mater with their fellow Sailors, Soldiers or Airmen.

The losing team sings first with the victorious team standing behind them. They then run across the field to the winning fans and the winner sings their Alma Mater with the losing team behind them returning the same respect. Attending one of these games in person should be on your bucket list.

Miami belongs with both Ohio State and Oregon as the elite teams thus far this year. However, Miami coach Mario Cristobal's tendency to make bad calls in closing out games will cost him again. Is Ohio State better this year than last? Is Bill Belichick's North Carolina team the worst power 4 conference team after UCLA upset Penn State?

I was not going to do a deep dive on what happened to Penn State until a lot of people asked my opinion in church and more at the grocery store Sunday morning. I will temper my thoughts a bit but suffice to say it was embarrassing, a disaster and the most unacceptable loss by a Penn State football team in over fifty years. That's counting the 10/2021 nine OT loss to Illinois and the 10/2004 6-4 L to Iowa.

If UCLA ends their season 3-9 it will be considered a better year than Penn State somehow ending 9-3. UCLA's offensive coordinator had been on the job for all of four days matching wits against the highest paid defensive coordinator in all of college football. Jim Knowles' defense gave up 435 yards to a team that never had a lead in any of their four previous games.

I realize Tony Rojas was hurt but PSU has no less than six players on defense that are going to be drafted by the NFL. I also know they had to travel cross country as Oregon did the week before and Washington just traveled to Maryland and beat the undefeated Terps. I am not even going to go to the offensive play calling with three more high NFL draft picks in the backfield.

This all leads to the question of James Franklin's future at Penn State. Reports run from \$50M to \$65M to buy out his contract. I don't believe Penn State or a deep-pocketed booster will pay that much money. I mentioned last week that the majority of fans are content with 8-10 wins a year and that being good is good enough. That's not to say Penn State won't immediately take the \$2M another school will pay to have Franklin come coach for them.

The BIG is about to get into the private equity business where corporations will be investing in the league and it will be a tiered system rewarding the better schools in football with more money. This is totally separate from broadcasting rights. Ohio State, Michigan and to some extent Penn State and Oregon will get more money than the other BIG schools. More on that in another article.

The Baltimore Ravens were the pre-season Super Bowl favorites and are still favored to win their division with a 1-4 record. The AFC North is the Steelers to lose. The Washington Commanders play as well as a team than any other and have Jayden Daniels back. Drake Maye looks a lot like a young Tom Brady in the Patriots uniform. Don't wake up the Colt's Daniel Jones.

New York football is a dumpster fire as the Jets are the league's last winless team. The Giants blew an 11 point lead against the previously winless Saints. I hope they aren't both losing for a chance to draft Drew Allar or Arch Manning!

My top 5 NFL teams are the Lions, but their next 5 games are brutal. Buccaneers with Baker are a fun watch. Eagles have some impressive but ugly wins. The Bills have only beaten the Ravens, Jets, Dolphins and Saints. The Jaguars after Trevor Lawrence's TD beat KC looking like a drunk Thanksgiving backyard football touchdown.

It's been a tough week for Philly fans as their big sticks didn't play with the intensity needed in the baseball playoffs. It's the same thing every year in the playoffs and a healthy Wheeler would not have made a difference. The Dodgers lineup is loaded with league MVP's and their pitching suddenly morphed into the best staff in the playoffs. This isn't taking into account that they have a first ballot Hall of Famer hanging out in their bullpen.

Culver to Host Damaged License Plate Replacement Event in Middleburg

Sen. Lynda Schlegel Culver (R-27) will host a Damaged License Plate Replacement Event on Friday, Oct. 10, 2025, from 11 am to 1 pm at First United Church of Christ, located at 8671 Route 522, Middleburg.

The event will provide residents with the opportunity to have their license plates inspected by local law enforcement. Plates that are peeling, blistered, discolored, or unreadable from 50 feet away may qualify for a free replacement.

“This event makes it simple for residents to replace damaged plates at no cost, ensuring their vehicles remain safe and compliant with PennDOT regulations,” Culver said. “I encourage anyone with a plate showing wear or damage to stop by.”

Police officers will be on-site to determine if plates meet the criteria for replacement and will help complete the necessary paperwork. Replacement plates will be mailed directly to vehicle owners by PennDOT once applications are processed.

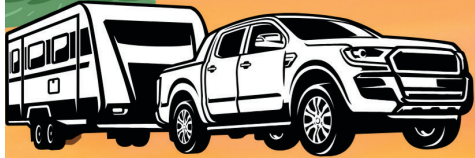

Happy 90th Birthday, Shirley Goss!

On her 90th Birthday Shirley Goss was serenaded by Bob Gift and given a big hug to welcome her to the Nifty 90's Club!

Shirley Goss celebrated her 90th Birthday with giant gold balloons waving in the wind on her porch. Her family gathered to acknowledge this milestone birthday as Shirley entered the Nifty 90's Club. Her living room was filled with well-wishers. The mantle was jam-packed with birthday cards. Of course, there were snacks and a ½ chocolate and ½ white cake, but no ice cream. Neighbor Bob Gift with guitar in-hand serenaded her with the Birthday Song as the family joined in. Bob sang several other tunes including "Somewhere Over the Rainbow."

Shirley was born on September 22, 1935 in the upstairs bedroom at her Grandparents Hackenberg's fruit farm in Middleburg. "I weighed 10 pounds and was delivered by Dr. Ulrich." With encouragement, Shirley reminisced about her memories of living in Paxtonville. "I went to school at the 2-room Paxtonville School House until 9th grade. Then I went down to Middleburg High School. My teachers were Miss Eichman and Mr. Buoy. Both were good. You couldn't get any better than Miss Eichman! My mom, Mary (Weirick) Hackenberg went to the Paxtonville School House as well. Fay Higgins was her teacher."

Shirley told about some of the games they played. "We used to sled ride down the big hill directly behind the school. There was a small hill behind the big one. The kids would yell, 'Second hill are coming!' I remember Dean Musser sledding down the hill when he hit his head on a tree. There was blood all over!" Another fun game was tossing balls over the school house roof and calling out, "Alle over!"

Jane Graybill, Nancy (Mitchell) Treaster and Shirley would walk to the state road (Rt. 522) and back past Lester Zechman's place. To the left there was an old swimming hole. The whole Paxtonville gang went there. Even Irma Popeano, who was older than me, went swimming there.

"One time my friend, Jane Graybill was quarantined for glandular fever. I would sit on the porch and talk to her through the window." Jane lived in a house that previously was owned by Mr. Buoy. It was built from a Sears house kit. There was a family connection to the house as it changed hands: Buoy > Graybills > Kevin Kinney > Wendy Hoffman (Shirley's granddaughter) > Eric Pyle (Shirley's grandson).

The T.W. Erdley Store was the hub and everyone hung out there. "The guys loafed in the back. They had ice cream, snacks, penny candy in jars. There were really nice shoes for sale especially moccasins. They had a lot of everything. I bought my first automatic washing machine at T.W. Erdley's Store. I missed it when the store was gone."

Many years later, practically the whole town came out when the former T.W. Erdley Store, at the time a church, burned down. Yvonne Goss recalled, "I lived right behind it. I could feel the heat. It even melted the siding of Eleanor and Denny Walter's house beside it."

Another memory was of Mrs. Frame's General Store that was located on the corner of Paxton Street and the Paxtonville Road "Everyone loved their candy case." Later, it was owned by her niece, Debra Folk and husband Tim. It is currently the home of Donnie and Brenda Lepley.

And the stories kept coming. "We used to have a Paxtonville Carnival in the big field (catty corner from the Park where Heather and Eric Wagner currently live). Everyone came and it was full of people. Everyone in the community helped. Grandma Hackenberg and Marie and Harry Renninger served food out the side door. There was a big parade during the Carnival. Grandma Weirick said, 'Don't be so proud (shy). Get in the parade!' I wore a poufy pink dress."

After the carnival was over, the folk would get together to count the money. She also remembered a time when a "bunch of guys from Paxtonville were invited to the TV show, Welcome Travelers, to talk about the carnival. The show donated playground equipment to the park."

The Roxy Theatre was another special place in Paxtonville. "My mom watched the silent movies with a live piano player. But that was before my time." The Roxy was also special for another reason. She met her husband, Leonard Goss there. "I thought he was a good-looking guy. He would go to the McClure Pool and get a dark suntan. He was even Prom King at McClure High School."

In 1963, Leonard and Shirley Goss moved into their home on Paxton Street in Paxtonville. They had four children when they moved there: Tony, Cindy (Pyle), Yvonne, and Doug Goss. She has 10 grandchildren and numerous great-grandchildren and even great-great grandchildren.

"I never had a dishwasher. I always washed the dishes by hand. I never made the kids wash dishes."

Frank and Amy Graybill owned the house where Shirley now lives. "Jane Graybill and I used to visit her grandparents here. I always loved their fire-place. Years later, I got to live here. I was so happy!"

Her son Doug was born in 1963. Shirley recalls the Paxtonville Brick Plant caught on fire. Many people from Paxtonville worked there. The fire scared daughter Yvonne because "it was a blaze of red sky."

Yvonne loved living in Paxtonville. "Paxtonville's the best! I would stop to visit and talk to all the guys- Dave Zimmerman, Tedd Wenrich, Ralph "Shummy" Shambach and Trossy and Tulip Hilbert. I would make my rounds chatting to all of them," she giggled.

Shirley's family and Paxtonville were also in the Gigantic 1989 Edition/ Newly Revised and Updated Guinness Book of World Records. "The youngest person to learn that their great-granddaughter had become a grandmother was Mrs. Ann V. Weirick (1888-1978) of Paxtonville, Pa, who received news of her great-great-great grandson Matthew Stork (b. Sept. 9, 1976) when aged only 88. She died on Jan. 6, 1978." They came and interviewed Ann Weirick. "I found the Guinness Book at a Thrift Store and scooped it up!" said Yvonne.

At 90, Shirley is one of Paxtonville's oldest residents. She has a loving family that takes care of her and visits her often. According to Charles Kuralt, "The love of family and the admiration of friends is much more important than wealth and privilege."
