Fernanders Sentenced To Life Without Parole For Double Murder

District Attorney Mike Piecuch announced that Christopher T. Fernanders, formerly of Paxinos, has been sentenced in Snyder County court to life in prison without parole for the killing of Heather Campbell and Matthew Bowersox.

Fernanders shot and killed Bowersox and Campbell on July 10, 2020, in the parking lot of a restaurant in Monroe Township, Snyder County. Fernanders was then himself shot and incapacitated by a good Samaritan who was at the restaurant at the time. D.A. Piecuch had previously issued a determination that shooting Fernanders was legally justified for self-defense and defense of

Prior to the sentencing on January 20th, Fernanders entered guilty pleas to two counts of first-degree homicide, an offense that carries a mandatory sentence of life without parole. As part of the plea agreement, Fernanders withdrew his pretrial motions and waived most grounds for appeal. The District Attorney's Office then withdrew its notice of intent to seek the death penalty. President Judge Michael H. Sholley accepted the plea agreement and imposed the sentence. The District Attorney's Office negotiated the plea agreement after consultation with the victims' fami-

D.A. Piecuch said, "Fernanders acted with premeditation, and with malice, and without any justification in murdering Heather Campbell and Matt Bowersox. In doing so, Fernanders destroyed their families and his own, not to mention traumatizing everyone at the restaurant forced to witness his brutality. This sentence can't bring the victims back, or undo any of the trauma Fernanders has caused. But it does put an end to the legal proceedings and it does mean that Fernanders will never again see the light of day as a free man."

D.A. Piecuch added, "I am grateful to the good Samaritan who prevented Fernanders from causing any further harm that day, and to the generous people who came out of the restaurant to give aid and comfort to Heather and Matt before first responders arrived. As always, I am thankful for the law enforcement officers and first responders who run towards danger when it happens. The Pennsylvania State Police and all the departments that assisted in the investigation did an excellent job, which directly resulted in today's resolution. Most of all, I want to extend my deepest condolences to the friends and family of Heather and Matt.'

Punxsutawney Phil: The Famous Weather Forecaster

On February 2 of every year Punxsutawney Phil, the esteemed weather prognosticator, will make his annual prediction on the length of winter. This year on Groundhog Day, the festivities will take place on Gobbler's Knob in Punxsutawney Pennsylvania to witness Phil's prediction. Punxsutawney Phil will be

roused from his burrow at 7:25 am, observe the weather conditions, look for his shadow, and make his prediction for 2022.

At this point, the event will be held live. There are many fun activites leading up to the prognosticating announcement. Some include Lunch With Phil, The Groundhog Ball, The Groundhog Members Reception, The Annual Groundhog Banquet, and visiting the Hogspitality Village.

According to legend, if Punxsutawney Phil sees his shadow when emerging from his burrow, then there will be six more weeks of winter. If Phil does not see his shadow, then he predicts an early spring. Phil speaks only to the President of the Groundhog Club in 'Groundhogese." Only the current president can understand Phil. His prediction is then translated and broadcast to the entire world. Follow the event on TV, online, Twitter, or Facebook!

Punxsutawney Phil, the Prognosticator of All Prognosticators, is never wrong in his prediction! Sometimes, during the excitement of the activities on Gobbler's Knob the President misunderstands Phil and relays in the prediction inaccurately. After the celebration, Phil is returned to his home in the town library where he lives with his "wife" Phyllis.

How did Punxsutawney Phil rise to fame as the Weather Forecaster Extraordinaire? Well, it all began in 1886 when a lively and fun-loving group of groundhog hunters dubbed themselves "The Punxsutawney Groundhog Club." One member was the editor of the local newspaper. In his paper he proclaimed Punxsutawney Phil to be the one and only weather prognosticating groundhog. Thus, Phil became a renowned weather forecaster and his fame has spread throughout the world.

For 136 years, Punxsutawney Phil has been a weather prognosticator and making his predictions. All other groundhog weathermen are denounced as imposters! Each summer Phil drinks a magical punch during the Annual Groundhog Picnic. This mysterious Groundhog Elixir magically adds seven more years to his life. Typically, a groundhog's life span is only 6-8 years. Punxsutawney Phil is also the heavy-weight of groundhogs weighing 20 pounds and measuring 22 inches long. The average groundhog weighs only 12-15 pounds and is 20 inches long.

Punxsutawney Phil even has his own special vehicle called the "Philmobile." This distinctive bus seats members of the Inner Circle inside with a specially-designated seat on the outside so Phil can be seen in parades. Sometimes, during summer parades spectators become alarmed when they spot Phil lying flat on his back with his legs pointing toward the sky, looking very much like a dead groundhog. However, that is just a ruse and Phil is merely cooling himself off-in true groundhog style.

So, with all this wintry weather we wait with baited breath for Phil's prediction! What will it be? Six more weeks of winter...or six weeks until spring? What's your preference? "Snow-time" or perhaps a warm and filling bowl of groundhog stew! Only the shadow knows...Punxsutawney Phil's shadow.

Country Cupboard, a 77,000-square foot restaurant and gift store, has been a mainstay of the area since 1973. Over the years, the family-owned restaurant has been host to family reunions, class gatherings, holiday meals, large-scale meetings, and weekly breakfast, lunch, and dinner stops for many

For nearly five decades, Country Cupboard has acted as an unofficial greeter and welcomed visitors to the area, many who returned often for the delicious, home-cooked meals, popular buffet, and relaxing atmosphere. The Shops also enticed customers to browse their many wares and feature Country Home & Interiors, a Greenhouse & Outdoor Living Shop, Women's Boutique, Candy & Confections and the Pantry

"I am very saddened by the news that Country Cupboard will soon be closing its doors. For almost 50 years it gathered us together to dine with family and friends and offered us meeting rooms to collectively learn and connect with each other.. Country Cupboard evolved into a unique destination spot for visitors from all over the world, contributing significantly to our local economy," said Union County Commissioner Stacy Richards. "We were so fortunate to have this unique resource in our community."

According to Baylor, there were many contributing factors that led to the decision to ultimately close the Country Cupboard. During the pandemic, restrictions impacted business, food costs soared, and it became difficult to hire and keep employees. Staffing decreased from a pre-pandemic 300+ employees to 140. The decrease in the volume of customers and buses also affected business.

The company adapted by limiting services, closing the restaurant on specific days, adjusting hours, and last minute closures due to staffing

"There isn't one factor that led to our family's decision to close Country Cupboard. There are many reasons why we are announcing this sad news. Yes, food costs have skyrocketed. Yes, it's extremely difficult to hire and keep employees in today's job market and yes, restrictions from the pandemic made it incredibly difficult to serve our customers."

Continuing the press release states, "But all of those mitigating factors brought us to this day, much earlier than expected.'

The Baylor and Hamm family hopes to transition as many employees as possible to other Baylor-Hamm owned businesses such as Best Western Plus, Country Inn and Suites by Raddison, and Matty's Sporthouse Grill or into new careers.

"Our employees mean the world to us. We owe our gratitude and respect for the long hours and hard work they've given to Country Cupboard, especially during the past two years.

Baylor also states, "Given the current staffing crisis, Country Cupboard will do its absolute best to remain open through February. We hope this time frame gives our employees a chance to transition."

"I am saddened to hear of the closing of Country Cupboard, a truly iconic regional business. Country Cupboard has been a destination for many people locally as well as a huge draw that brought visitors to our area, who then went on to support other

businesses as well as explore the tremendous assets of our region.." stated Union County Commissioner Jeffrey Reber. "The Baylor and Hamm families have been wonderful community partners as well as created jobs for thousands of people throughout the years. I have complete faith that the ownership of Country Cupboard will go above and beyond to help their employees find new opportunities and I look forward to seeing what is next for the property."



It features 181 feet of ground ladders, a 300 gallon water tank, 2,000 GPM pump, a hydraulic generator, side roll and frontal impact protection, and seating for 6. It is expected to be delivered in the Summer of 2023.

The new 100 foot ladder truck will enable firefighting in multi-story buildings. It will reach up to a 10-story building. The tower platform facilitates safer rescue operations at heights.

"In and around the Borough of Selinsgrove, we have several high oc-cupancy, multiple story dwellings such as nursing homes, dormitories, and hotels. This truck will not only allow us to fight fires at hard to reach elevations, it will provide a means to safely rescue victims from upper stories with the added benefit of safer working conditions for the firefighters," explains 2nd Lt. Sean Christine. "This vehicle represents an investment in community safety unlike anything we have seen in DH&L's 148 year

The new Pierce Arrow ladder truck will replace the 24 year old 1998 Seagrave stick ladder truck currently in service. The Seagrave ladder truck will be sold with the profits being used toward the purchase price of the

The truck committee consisting of Chief Brandon Ulrich, Deputy Chief Jason Kline, Asst. Chief Colin Rice, Battalion Chief Jason Kaufman, Captain Derrick Cook, 1st Lt. Tyler Loss, 2nd Lt. Sean Christine, and firefighters Monty Anders and Jeremiah Hoover researched options for over one year before deciding on the Pierce.

The ladder truck is being purchased with funds from the fire taxes from Selinsgrove Borough and Penn Township. Proceeds from DH&L fundraisers such as Selinsgrove Oktoberfest, DH&L Winterfest, Golf and Cornhole Tournaments, and the carnival will also be used toward the purchase price. A River Rat's Ramblings: A River Mouse 1952

At age 5, my evolution as a River Rat was beginning. The early summer of 1952 was beginning to feel a little different; I could feel my mother starting to loosen her apron strings. I was now allowed to cross North Front Street and go down to the river all by myself. North Front Street ended at our house so it was not a busy road but for my mother it had been a line in the sand between me and the river. One day mom said, "If you're careful, it's OK with me if you go down and fish for Rocky's off the coal barges." (Rocky's were Rock Bass).

There was an outfit of coal barges docked at our boat landing because our landing was one of just a few that had a road from Front St. down to the river. It was necessary to have that access to the river in order to truck the coal from the barges. There are four main components that make up a commercial coal dredging outfit. First was the dredging barge that dredges the coal from the river and piles it onto the coal barges. This piece of equipment was always called the Digger because the coalmen always dug coal not dredged coal. The second piece of the outfit was the paddle wheel tug called the pusher. This barge was used to push the coal barges around the river. Third were the coal barges that transported the coal on the river, these were simply called the coal flats. The fourth piece of equipment in the outfit was a barge called the loader. This was a stationary barge docked at the boat landing and removed the coal from the coal flats and loaded the coal into dump trucks. It was the loader that held the Rocky's as it was only moved in or out from shore based on the changing

No matter what time of the day, armed with my 4 ft. steel fishing rod, a level wind reel spooled with black casting line, a #6 snelled hook and a tin can of worms and you were rigged for catching Rocky's. You could usually average 2 Rocky's for every worm. At this point I should remind the readers, there were no bait stores to buy worms. You dug the worms you were going to fish with. I would spend hours lying on my belly on the front deck of the loader, hand lining my bait back to the waterline of the loader. I would wait for a few minutes and then a tap-tap on the line indicating a bite, wait, and then a steady pull from the fish, let a few inches of line run through my fingers and pull, setting the hook right in the corner of the Rocky's jaw. If you let them run to long, they would swallow the hook and I would have to keep and clean them as they would die with the hook in their gut. If I was going to keep one fish then I needed to keep enough for our family to have a meal of fish.

I was taught early on from my father, if you keep it you clean it. Later on that applied to hunting also. Dad showed me how to scale the fish, gut them and cut their heads off. (My mom's rule). Mom would soak the fish overnight in salt water to remove any blood from the fish. The fish had to be eaten in the next day or two as the freezer in our refrigerator was only large enough to hold 4 ice cube trays. Mom would pat the fish dry, brush the skin with an egg/milk mixture, dredge the fish in a flour/corn flake crumb mixture, and fry it in a cast iron pan with hot oil until the skin was golden brown and crispy. I was taught that if before frying you cut the skin along the back bone when it was done the skin and meat pulled away from the bones much better. Our fish was usually served with home fries and a veggie. (There were no frozen French fries in those days.)

My sisters and mom did not like to eat the skin so Tim and I usually got to eat theirs. Brother Tim thought the fins tasted like potato chips so he usually got all the fins and tails. Tim was only three and the baby of the family and very spoiled. Come to think of it he's now 73 and still the baby of the family and may be still a little bit spoiled. (Sorry brother! I just couldn't help myself.) The start of the summer of 1952 was great being able to fish for Rocky's and now I was able to go out in the green boat fishin with my dad. I'll save that topic for another story.


