Sewage Line Rupture Causes Crisis Hilly Ridge Sales Wins Director Midd-West Homecoming Week-Award at Bloomsburg Fair end Set for October 4 and 5, 2024



A major sewage line ruptured on Sunday near the East Snyder County Sewage Treatment Facility in Selinsgrove. The rupture spilled raw sewage into Penns Creek and the Susquehanna River.

The 20 inch pipe that carries up to two million gallons of sewage daily from Selinsgrove, Shamokin Dam, Monroe Township and Penn Township was temporarily repaired on Sunday night and full repairs are scheduled for this week.

Authorities are still asking residents to reduce their sewage usage until permanent repairs are completed. Suggested measures include limiting dish washing, laundry, and limiting shower time. Toilet use is still permitted. The public is advised to avoid Penns Creek and the

Susqueĥanna River south of Selinsgrove due to potential contamination. The work impacted SR 11 & 15 exit ramp to SR 35 on

Wednesday and a detour was set in place. DEP is advising that during the repair, more raw sewage may be released. Drinking water still remains safe but DEP advises avoiding river activities such as swimming, and boating for 20 miles downstream.






