Awakened by the smell of fresh perked coffee, I shook Tim awake and said, "It's Saturday, we have to go to Gemberling's boat landing and see how many eels they got last night." Tim and I shared a bedroom and a full size bed that was right over the kitchen. With the heat register opened we got all the good smells coming from the kitchen. We hopped up, put on our play clothes, pulled the covers over the pillows, brushed our teeth, and went down stairs... all in about 5 minutes.

"Good morning boys, how'd you sleep?" mom asked. "Good, got to go check eels," I replied. "Breakfast first," came her voice from the pantry. On the table were two cereal bowls, two spoons, a glass bottle of milk from Selinsgrove Dairies and a box of Wheaties and a plastic bag of Puffed Rice. One half bowl of Wheaties on the bottom with the Puffed Rice on top of the Wheaties, just the way I taught Tim how to eat it. Now, I'd carefully pour the milk into the bowls until the Puffed Rice started to fall over the side of the bowls, a teaspoon of sugar and we

The expected, "Don't you boy's make a mess on that table," came mom's voice still in the pantry. Why do moms always say that when they know we are going to make a mess? Tim and I always had to have a box of cereal sitting in front of us while we ate breakfast, even though we couldn't read all the words. We finished our cereal almost as fast as we brushed our teeth.

"Ready to go over to Gemberlings mom," I said as we grabbed our coats off the rack by the back door. "Not yet boys, you have to wait for your sisters," mom said looking directly at me. Good Lord in Heaven, I thought, the eels will all be cleaned til we get there. Then, in my most grown up voice I said, "Mom, the Gemberlings will all be there and Mrs. Gemberling always watches us while we're there." Mom thought for a moment, "OK, but Jimmy you have to take Timmy's hand and your river boots are on the back porch." Dragging Tim by the hand we went out the door, jumped into our boots and were on our way across the yard to the Gemberling's boat landing.

As we walked by our neighbor's house, Mary Kemberling called from her porch. "Jimmy, I would like one eel, but not a great big one." "OK," I replied. Mary and her daughter, Pauline, lived between our house and the Gemberling's house. All three of our families, Gemberlings, Kemberlings, and Charles's had their roots deep in Isle of Que soil. Lynd Gemberling was a cousin to my grandmother Matilda Gemberling Charles. As Tim and I got to the Gemberling's boat landing, Lynd

and his son Bud were just pulling in with their catch of eels. Waiting at the boat landing were Lynd's wife Hilda and their youngest son Wayne. They had brought all the gear for cleanin eels. A big river rock sat beside a pile of sand next to a sycamore tree at their landing. They had 32 eels which was a fair catch for 1952, but 20 years ago they would have caught 100 to 150 eels a night. Now, the cleaning process began. First, Lynd would

get some eel slime on his hands, press the palms of his hands onto the pile of sand and reaching into the boat of wiggling eels with one swift motion he would grab an eel and smash it's head on the big rock. Lynd now handed the stunned eel to Bud who wedged the head between two 16 penny spikes in the sycamore which held the eel by its gill plates. With a precision cut of his knife Bud slit the eel from the gill plate down its belly all the way to the tail. Bud now cut all the way around the eel just below the gill plate and with a pair of pliers in each hand grabbed a piece of skin on each side of the eel and stripped the skin all the way to the tail. He now cut off the tail and head – threw them in the gut bucket. He handed the skinned eel to Wayne who washed it in clean water and put it in a large porcelain dish pan. If there was eel row (eggs) in any of them the sack of row was removed and placed in a clean pint jar. After they had cleaned several eels I told Hilda that

Mary wanted one eel. She pulled one out, wrapped it in newspaper, and said it would be a quarter. I ran up to Mary's house and delivered the eel and got two dimes and a nickel. When I gave the money to Hilda she handed the nickel back to me for taking the eel to Mary. I told her it wasn't necessary but she insisted. What I hadn't mentioned was that Mary had given me a nickel for bringing the eel to her. Ten cents for a 50 yard delivery was good money. My sisters had shown up and taken my brother home so I didn't have to

watch him. I stayed until the last

eels were cleaned and sold. A man from the Moose Lodge bought 10 eels and another from the Odd Fellows Hall bought 5. I wondered about the man from the Odd Fellows as he looked perfectly normal to The actual catching of

eels will have to wait for my next story, it's called fishin for eels but there is no hook and line involved.

Doctor's carriage recently donated to the Mifflinburg Buggy Museum by Marc Schefsky. The museum is open Saturday and Sunday from 1-4 pm from May 1-October 31.

The Mifflinburg Buggy Museum added quite a few new pieces to its collection last year. In December of 2020, Ginny Rech of Marysville donated a Bachman/Hopp carriage. Ginny owned the buggy for more than 50 years and felt that the buggy should be returned to its "home" in Mifflinburg. The frame was built by M.L. Bachman of Lebanon while the top of the carriage was constructed by the Hopp Carriage Works in Mifflinburg. In April, the museum received "on loan", a Jacob Gute-

lius sleigh beautifully restored by Vicksburg Buggy. The sleigh was in very poor condition when purchased at an estate auction. After months of pain-staking work by Isaac Reiff of Vicksburg Buggy the piece has been re-

stored to its original glory.

July saw the donation of an industrial sewing machine from the Boalsburg Heritage Museum. The museum was "re-imaging" its collection and decided this machine would be a great addition to our buggy museum. The sewing machine was originally housed in the James Logue Blacksmith and Coachworks in Boalsburg and would have been used to sew the upholstered parts of buggies such as seats and tops.

A 1926 Ford Model T Suburban was donated in October by Lawrence Samartin of Texas. Mr Samartin originally contacted board members at the buggy museum asking if they would be interested in purchasing the vehicle for our collection. However, funds were not available for such a purchase. Eventually, Mr Samartin decided to donate it to our collection.

Wondering why the buggy museum would display a car amongst its collection of 19th century buggies? Mifflinburg was actually home to Mifflinburg Body and Gear Co (currently Rusty Rail) that manufactured the iron work and bodies for both buggies and automobiles! The donation of the Suburban was a welcome "homecoming".

In November, we added another carriage to our collection due to the generosity of Marc Schefsky. This carriage was made in Hughesville by M. Gillis for a local doctor who had used it to make housecalls in the community. The buggy had a circuitous route to our museum. It was purchased by Marc's mother as a gift for his father, Dr. Harvey Schefsky, where it was proudly displayed in their home for years. Later the buggy "welcomed" guests to Williamsport as it was displayed in the lobby of the Genetti Hotel. It was then donated as an exhibit to the Williamsport Transportation Museum and housed there until its recent closing. At that time Marc contacted us and asked if we would like to add this beautifully-restored piece to our collection. Marc transported and donated the carriage in memory of

vey and Alaine Schefsky. Financial donations help us keep the Mifflinburg Buggy Museum doors open. We operate solely Museum doors through the efforts of volunteers. There is no paid staff. Museum admissions, fund-raising events, paid memberships, and additional donations have allowed us whittle down our mortgage to \$72,000. We now have an endowment standing at \$53,000 which once fully funded, will allow us to cover our everyday expenses. 
Maple Tours & Tastings Edited by Kay Poeth
