Race day registration will be held from 7:30-8:45 am. Race starts at 9 am. Awards ceremony will be held immediately following the race in the middle of the Market Street Festival. \$25 per participant.

During an accident sliding into a shallow pond, Tyler Snader shattered his 7th spinal vertebra and fractured his 5th and 6th vertebrae. After surgery, the muscles below Tyson's chest are expected to remain paralyzed. He is beginning physical therapy in Philadelphia and hopes to defy all odds. Tyler Snader has a free-spirited, fun-loving, and optimistic outlook on life. He was a star on the Township CC team and went on to run at Susquehanna University.

Tyler has a wife Lacey and son Hudson. The family faces many financial challenges including uninsured medical expenses, creating an accessible home, purchasing an accessible vehicle, and providing ongoing care throughout Tyler's recovery. The family appreciates the support, thoughts, and prayers during this difficult time.

Hosted by The Mifflinburg & Selinsgrove Cross Country Teams, net proceeds from the race will benefit the Christopher and Dana Reeve Foundation for curing spinal cord injuries and the booster clubs for the Selinsgrove and Mifflinburg Cross Country teams.

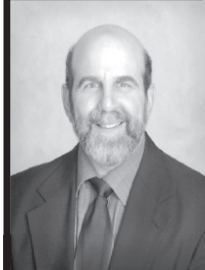

THE 40TH ANNUAL NATIONAL OPEN JIM NACE MEMORIAL THIS WEEKEND AT SELINGSGROVE

Usually, the National Open weekend is a one-day show, but with the 40th running of the race, which has had the Nace name added to it for a number of seasons, is has become a two-day show. This Friday night will feature the 410-sprints will run for 25-laps and pay the winner \$6,000, with that the winner an automatic qualifier& in the redraw for Saturday's show. The super late models will run their final point race and also race for 25-laps for \$3,000 to win. Bryan Bernheisel pretty much just has to take a green flag on Friday night to clinch his second super late model title at Selingsgrove his other came in the 2018 season. With two sprint shows the points will come down to maybe six drivers with Blane Heimbach having the lead going to the weekend by 130 over Lucas Wolfe, and Mike Walter. Getting back to the race, the 40-lap feature will pay the winner \$26,000 which was the number Nace drove to three of his five track title. In 410-sprint races so far this year at Selingsgrove Anthony Macri scored the win in the Ray Tilley Classic on April 24th with a small field of 16 drivers on hand. May 26th race had Gio-Scelzi scored the win with 20 drivers on hand Danny Dietrich won the Speedweek show with a field of 23 drivers. July 23rd and August 27th races went to Heimbach with only 15 and 16 drivers on hand, while the Labor Day Sunday show had Brian Brown getting the win over a field of 22-drivers. We can only hope a nice field of drivers sign up for the biggest paying unsanctioned sprint race in the state for this race on Saturday. The last two tears Anthony Macri has won the Nace Open event with fields of 27-drivers in 2020 and 33 drivers last year. Part of the Saturday show will have the 305-sprints which will be their final point show of the season and either Ken Duke or Garrett Bard are in position to get the title, there part in the Nace race over the last two tears had Bard winning in 202 with 37-drivers on and last year Derek Hauck won over a field of 29 drivers.

Last Saturday was a bit of a disappointment for the 305 division at Selingsgrove speedway, with a very good extra paying race for this division which had the winner collecting \$900 and it was \$450 just to start the feature, which all of this is almost double of what they usually race for. The 30-drivers on hand was a good quality of drivers, but only nine days earlier 45 drivers were on hand for a regular show at Port Royal. This is hard to figure this thing out, but many drivers who decided to do something else missed out on a great chance to make some extra money in a division that every once in a while, drivers will talk about the lack of pay for this division, you just missed a good event to race for some good money so shame on you. Austin Reed was glad for the opportunity to race for big money has he scored his second big paying 305-sprint race this season. Back on Saturday July 3rd he won \$800 at Clinton County speedway over a field of 35-drivers. Reed and hopefully more will be at the next event that has extra money at Port Royal on Saturday October 22nd.

It was Yoder Nation night again at Selingsgrove speedway as Dylan Yoder led all 25-laps to win his second feature of the year there and third of the year in the super late model, with his

win the other week at Lincoln speedway. Andre Yoder who has already won four Limited late model features at Selingsgrove official clinched the track title with a second-place finish last Saturday. Andrew has won three of these titles at Port Royal, but this year set a goal to win one at Selingsgrove speedway. For the second Andrew has four wins and two second in the six races run with two other events getting rained out, Andrew has also scored wins at Port Royal, Clinton County and Lincoln speedway's this year in the class, but would love to had a super late model win soon. Dylan has had another consistent season getting four hard charger awards this season at Selingsgrove, one that paid him \$630 all from Schick's Automotive the sponsor. The last two races Dylan has won he has led all laps 40at Lincoln and 25 at Selingsgrove. The top five in the super late model feature had a mix of father and son and a pair of cousins, Dylan Yoder and Andrew cousins, placing first and fourth Bryan and Jim Bernheisel father and son placing second and fifth. Both late model classes have had good car counts most of the season, with last Saturday 23 supers and 21 limited lates.

410-sprint car counts were good last weekend with the Thursday show at Baps 29drivers with Brett Marks the winner, Friday night All-Star sprint race at Williams Grove 33-drivers with Lance De-wease the winner and Saturday at Lincoln with 50-drivers on hand and Brett Marks getting another win, Aaron Reutzel won at Lernerville speedway on Saturday with 40-drivers on hand. A special 358-sprint race was held at BAPS speedway on Saturday with 36 drivers on hand with Doug Hammaker getting the win.

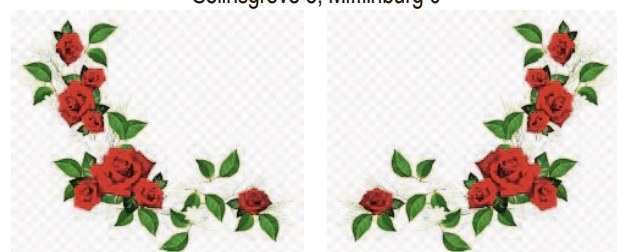

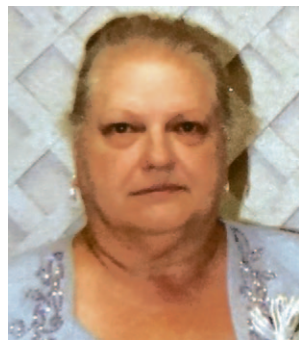

Farmers: Don't Forget the Cover Crops

Many farmers have harvested or are harvesting corn silage right now, whether planned or not. Other farmers will soon be done harvesting their horticultural crops. Soybeans will be harvested soon as well. Regardless, the Snyder County Conservation Districts strongly urge the planting of cover crops when cash crops are not growing on farmers' fields.

Cover crops help farmers do many things. Cover crops armor the soil from the autumn rains, winter snows and spring showers. Cover crops trap manure and fertilizer nutrients from leaching that would enter our surface and ground waters. Cover crops feed beneficial microbial life during the year when a cash crop is not present. Legume cover crops supply nitrogen for the next cash crop. Other advantages include: 1.) Reduce soil compaction, 2.) Build soil organic matter, and 3.) Improve weed control.

PA regulatory requirements state that cover crops must be planted, at minimum, on portions of harvested corn silage and low residue fields 100 feet from any streams or waterbody.

For more information about cover crop selections, mixtures, and rates, contact a reputable crop consultant, professional agronomist, reliable seed dealer, nearest Penn State Extension office, the local USDA-Natural Resources Conservation Service (NRCS) field office or your county conservation district office.

Manure Management Plan Workshop For Farmers And Others

The Snyder County Conservation District will hold free workshops to show farmers, livestock owners and horse operations how to write their very own manure management plans (MMPs).

Workshops will be held on Tuesday, October 11, at the Conservation District Office, 10541 Route 522, Middleburg. One workshop will be held from 9:00 a.m. to 12:00 noon and the other workshop will be held from 6:00 p.m. to 9:00 p.m. Participants will leave the workshop with knowledge and information to complete a manure management plan that meets current PA Department of Environmental Protection (DEP) regulations. MMPs are required by any person who raises or boards animals, produces or receives animal manure, regardless of animal type (equine, poultry, livestock, exotic animals, etc.) or number. We encourage animal operations to start working on their plans as soon as possible. A demonstration on how to use PAOneStop (Penn State's web-based mapping site) to create MMP maps is also planned.

Snyder County Farmers, Interested in Ag. BMP? Funding Possible!

Pennsylvania farmers are hearing news about the need to reduce nutrient and sediment pollution in our streams, rivers and the Chesapeake Bay by the end of 2025. PA Farmers also hear that additional funding is available for farmers to install conservation practices that improve their operations as well as water quality. What is the next step?

In Snyder County, the Snyder County Conservation District (SCCD) is making a list of farmers interested in improving their farm operations with the installation of conservation practices, a.k.a. best management practices (BMPs). These BMPs include manure storages and stacking areas, streamside riparian buffers, barnyard improvements, streambank fencing, milkhouse wastewater treatment, silage leachate treatment, stream crossings, roof gutters and outlets, cattle walkways, streambank & fish habitat restoration, and pasture watering facilities.

Once a farmer contacts the SCCD and its staff visit the operation, both farmer and the SCCD can work together to see what BMPs and plans are needed, how much it costs, and how to secure potential funding. SCCD District Manager Jason Winey notes that this is the largest amount of funding available for agricultural conservation practices in recent memory.

The 2022-23 statewide archery season runs from Oct. 1 to Nov. 12, continues on Sunday, Nov. 13, then goes from Nov. 14 to 18. It comes back in from Dec. 26 to Jan. 16, 2023.

Archers pursuing whitetails in Wildlife Management Units (WMUs) 2B and 5C and 5D, around Pittsburgh and Philadelphia, respectively, can start hunting two weeks sooner, get an additional Sunday and can go later into 2023. Archery season in those WMUs runs from Sept. 17 to Nov. 12, continues on Sunday, Nov. 13, goes Nov. 14 to 19, continues on a second Sunday, Nov. 20, and goes from Nov. 21 to 25. It comes back in on Dec. 26 and goes through Jan. 28, 2023.

“Pennsylvania’s archery deer season is an amazing time to be afield,” said Game Commission Executive Director Bryan Burhans. “With autumn’s vibrant colors and increasingly cooler temperatures serving as the backdrop, the season gives hunters the chance to chase whitetails before, during and after the peak of the rut. It’s clear hunters appreciate that opportunity and are taking advantage of it.”

Indeed, resident archery license sales hit an all-time high in 2020 and – while dropping slightly from that peak – still reached 341,885 in 2021. That’s the second-highest sales total of the last dozen years.

Non-resident archery license sales mirror that trend, with 2021’s total of 19,099 trailing only 2020’s record of 19,164.

Those aren’t the only archers in the woods either. Holders of junior and senior lifetime combination licenses can likewise participate in archery season and, with senior combo licenses at record levels, an untold number surely do.

Opportunity surely has something to do with that. The Game Commission added a seventh week to the statewide archery season in 2020, providing more flexibility and a chance to hunt deeper into the whitetail breeding season. Hunters will enjoy that extra time again this year.

Last season, hunters harvested an estimated 130,650 deer in the archery season (68,580 antlered, 62,070 antlerless). Week one was the most productive for antlerless deer, weeks five and six tops for antlered deer.

That archery harvest is important to deer management statewide, in all WMUS, without being too large, said David Stainbrook, Deer and Elk Section Chief for the Game Commission. He pointed out that many archers also are rifle hunters. If they take a deer in archery season, they’re just taking advantage of the seasons available and filling their tags earlier in fall.

“We continually monitor our deer harvest to ensure that our goals and objectives are still being met in each WMU,” Stainbrook said.

Opportunity doesn’t automatically equate to success, though, so to help hunters get the most from archery season, the Game Commission is offering some reminders and tips.

Archery hunters may use long, recurve or compound bows, or crossbows. Bows must have a draw weight of at least 35 pounds; crossbows must have a minimum draw weight of 125 pounds.

The Game Commission encourages hunters to spend as much time as possible afield this fall prior to and during the hunting seasons to scout and identify areas where deer are traveling and bedding and where fall foods are abundant. Food availability changes from year to year, and in areas where food is spotty, deer often move to find better feed. Hotspots change from one year to the next, even from the start to the close of the season, so tracking deer activity and keying in on food sources is important.

Bowhunters should practice with their equipment before the season starts, from the ground and/or an elevated stand, and take only responsible shots at deer to ensure a quick, clean kill. Archery hunters should take only broadside or quartering-away shots at deer within their maximum effective shooting range, which differs for each hunter depending on their skill level and type of equipment used.

Hunters may use illuminated nocks for arrows and bolts, as they aid in tracking or locating the arrow or bolt after being launched. However, transmitter-tracking arrows are illegal.

Tree stands and climbing devices that cause damage to trees are unlawful to use or occupy unless the user has written permission from the landowner. Tree stands – or tree steps – penetrating a tree’s cambium layer cause damage, and it is unlawful to build or occupy tree stands screwed or nailed to trees on state game lands, state forests or state parks.

Portable hunting tree stands and blinds are allowed on state game lands, but not until two weeks before the opening of the archery deer season. Hunters must remove them no later than two weeks after the close of the flintlock and late archery deer seasons in the WMU being hunted.

In all cases, tree stands on state game lands also must be conspicuously marked with a durable identification tag that identifies the stand owner. Those tags must include the hunter’s first and last name and legal home address, the nine-digit CID number that appears on their hunting license, or their unique Sportsman’s Equipment ID number. Hunters can find their number in their HuntFishPA online profile or on their printed license.

Hunters who plan to be afield on private property on the Sundays open to archers must carry with them written permission from the landowner to be there.

Safety tips for bowhunters

Make sure someone knows where you’re hunting and when you expect to return home. Leave a note or topographic map with your family or a friend. Pack a cellphone for emergencies.

Practice climbing with your tree stand before the opening day of the season, especially at dawn and

dusk. Consider placing non-slip material on the deck of your tree stand if it’s not already there.

Always use a fall-restraint device – preferably a full-body harness – when hunting from a tree stand. Wear the device from the moment you leave the ground until you return. Don’t climb dead, wet or icy trees. Stay on the ground on blustery days.

Use a hoist rope to lift your bow and backpack to your tree stand. Trying to climb with either will place you at unnecessary risk.

Don’t sleep in a tree stand! If you can’t stay awake, return to the ground.

Keep yourself in good physical condition. Fatigue can impact judgment, coordination, and reaction time, as well as accuracy.

Always carry broadhead-tipped arrows in a protective quiver. Know how to uncock a crossbow safely, too.

If you use a mechanical release with a vertical bow, always keep your index finger away from the trigger when drawing.

Follow the manufacturer’s recommendations for all equipment and check your equipment before each use.

Avoid walking with a nocked, broadhead-tipped arrow or bolt.

Cocked crossbows should always be pointed in a safe direction. Know how to uncock your crossbow at the end of legal hunting hours.

Always carry a whistle to signal passersby in the event you become immobile. A compass or GPS unit and map, matches or lighter and tinder also are essential survival gear items to have along. A flashlight with extra bulbs and/or a portable charger for the light and your phone also can be helpful.

Free online resources

To help hunters in being safe and successful, the Game Commission is offering two free resources.

The first is an archery safety course that provides instruction on tree stand safety, and safe and ethical shot placement. The course is available for free, takes about an hour to complete, and is found on the Game Commission’s Hunter-Trapper Education page (www.pgc.pa.gov/Hunt-Trap/Hunter-TrapperEducation), under “Pennsylvania Archery Safety Course.”

In addition, the Game Commission expanded its Learn to Hunt program this fall with two online seminars on archery hunting.

The first covers the basics of archery hunting. A recording of this presentation is available to view on the Game Commission’s Learn to Hunt webpage (<https://www.pgc.pa.gov/InformationResources/GetInvolved/GetStarted-Hunting/Pages/Learn-to-Hunt-Curriculum.aspx>).

The second seminar provides a more in-depth discussion on hunting tactics and is scheduled to be held live on Wednesday, Sept. 14th at 6 p.m.. Registration, which can be completed at the Learn to Hunt page, is required to view the course live. Once completed, the recorded course will also be available to view.

Venison care

While hunting in October often offers pleasant days afield, the warm weather also presents challenges for successful deer hunters.

One is making sure they wind up with high-quality venison for the table.

Deer harvested when the weather is warm should be field dressed quickly, then taken from the field and cooled down as soon as possible. Refrigerating is best. While hanging a deer carcass in a shady area might be fine in cooler temperatures, it’s not so good when air temperatures are above 40 degrees.

Additional information on warm-weather venison care, as well as instructions on deer processing and other tips, are available on the white-tailed deer page on the Game Commission’s website, www.pgc.pa.gov.

CWD regulations

Hunters who harvest deer within any of the state’s Disease Management Areas (DMAs) or its Established Area (EA) must comply with special rules aimed at slowing the spread of Chronic Wasting Disease (CWD).

There are six DMAs across the state, one of them – DMA 7 – is new for this hunting season. Created in April, after detection of a CWD-positive deer at a captive facility in Lycoming County, it takes in portions of Lycoming, Northumberland, Montour, Columbia and Sullivan counties.

The boundaries of a few other DMAs, meanwhile, have changed since last season, with the most recent of those impacting DMA 2 in southcentral Pennsylvania.

Because some of those changes became necessary after

publication of the Hunting & Trapping Digest that all hunters get with their license, hunters are advised to visit the Game Commission’s website at www.pgc.pa.gov to familiarize themselves with DMA boundary lines.

The EA, meanwhile, is within DMA 2 and includes portions of Bedford, Blair, Fulton, and Huntingdon counties. Approximately 90% of all CWD detections in the state have come from this area.

As a reminder, it’s illegal within a DMA and the EA to remove any cervid high-risk parts; use or possess cervid urine-based attractants; directly or indirectly feed wild, free-ranging deer; and rehabilitate wild, free-ranging cervids.

High-risk parts include: the head (including brain, tonsils, eyes and any lymph nodes); spinal cord/backbone; spleen; skull plate with attached antlers, if visible brain or spinal cord tissue is present; cape, if visible brain or spinal cord tissue is present; upper canine teeth, if root structure or other soft tissue is present; any object or article containing visible brain or spinal cord tissue; unfinished taxidermy mounts; and brain-tanned hides.

The parts-movement ban means hunters in a DMA and the EA must determine in advance what they’ll do with any deer they harvest. They can take them to a processor within the DMA/EA or to one included on a Game Commission-approved list for that particular DMA/EA, as those processors agree to properly dispose of the high-risk parts. Hunters can also dispose of high-risk parts within the DMA/EA in trash destined for a landfill. Or, while not preferred, they can quarter the animal and leave the high-risk parts at the kill site.

The meat, antlers (free of brain material) and other low-risk parts then can be transported outside the DMA and the EA.

Hunters getting taxidermy mounts must likewise take their deer to a taxidermist within the DMA, the EA or on the Game Commission list.

The processor and taxidermist list is available at the Game Commission website. Click on “Wildlife,” then “Wildlife Health,” then “Chronic Wasting Disease (CWD).”

There, too, hunters will find the locations of head drop-off bins within DMAs and the EA. Hunters can deposit deer heads – minus any antlers, double-bagged and with a legible harvest tag attached –there and have them tested for CWD for free. Test results can be obtained by calling the CWD hotline (1-833-INFOCWD) or visiting the CWD Results lookup page at <https://pgcdatacollection.pa.gov/CWDResultsLookup>.

Hunters can also explore opportunities to get Deer Management Assistance Program (DMAP) permits, which allow them to take up to two additional antlerless deer in areas where increased CWD surveillance is needed.

The Pennsylvania Board of Game Commissioners will meet Sept. 23 and 24 at the agency’s Harrisburg headquarters.

The meeting on Friday, Sept. 23 begins at 2 p.m. The purpose of this meeting is for the board to hear reports from staff. Public comment will not be accepted at this meeting.

Public comment – limited to five minutes – will be accepted at the Saturday, Sept. 24 meeting on a first-to-register, first-to-speak basis. Registration begins when doors to the Harrisburg headquarters open at 7:45 a.m. The meeting begins at 8:30 a.m. PowerPoint presentations are not permitted during public comment periods.

Following the conclusion of public comment, the board will take up its regular agenda, then will discuss new business.

The agenda for the September meeting is available at the Game Commission’s website, www.pgc.pa.gov. Under “About Us,” on the right side of the homepage, select “Events & Board Meetings,” then click the “September 24, 2022 Agenda” link.

The Game Commission’s headquarters is located at 2001 Elmerton Ave., just off the Progress Avenue exit off Interstate 81 in Harrisburg, Dauphin County.

Those unable to attend the meeting can watch much of it from home.

The meeting is scheduled to be live-streamed Friday and again on Saturday, following the conclusion of public comments. The livestream can be viewed on the agency’s YouTube channel.

Shamokin Dam Borough Building To Undergo Renovations

Plans to renovate the Shamokin Dam Borough Building are underway The majority of the \$178,000 in funds received from the American Rescue Plan will help to pay for the project, the remaining will be drawn from Borough reserves. The Borough office operations will remain on the main level and the office space currently occupied by Senator John Gardner, on the lower level, will be relocated to the main level. The police department will be relocated to the lower level with its own entrance and garage. A waiting area for the public will also be added at the police entrance. Enhanced technology security is a priority for this project.

As part of the overall plan, the existing police garage building would be fully renovated to house the Borough Council Chambers. The proposed plans include handicap accessible upgrades, new windows, flooring, paint, in both buildings, as well as site and parking upgrades. SBA Architects of Sunbury have been hired to oversee the project.

The plans include a list of possible upgrades that may not be financially feasible through this funding. According to Borough Manager Ed Hovenstine, “We do have a ‘budget’, but we are waiting for the architect to see how far that budget will stretch. Meaning we may not be able to do everything that we are hoping to do.”
