Receiving third place awards were Preston Arbogast in Criminal Justice; Jordan Brouse in Culinary Arts; Adam Snayberger in Plumbing; Blain Kerstetter, Nathaniel Sizer, Izaak Grodotzke, Kurtis Raker in Team Works. Two students received BYES at the District level, Chloe Eddy for Photography and Briana Bluhm in Painting and Decorating.

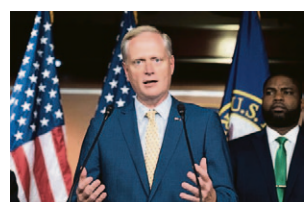

Keller Announces He Will Not Seek Re-Election

On February 28, 2022, Congressman Fred Keller (R-PA) announced that he will not seek re-election. The district map was redrawn and the 12th District now overlaps with U.S. Rep. Glenn Thompson in northwestern Pennsylvania and includes Snyder and Union counties. Running in the 9th District, would pit Keller against U.S. Rep. Dan Meuser. After consideration, Keller announced that he will not challenge Congressman Meuser for the 9th District seat in the newly redrawn map.



Keller released the following statement: "With control of Congress—and the direction of our nation—at stake, this election is bigger than any one person. Rather than pit Republicans against Republicans, which the congressional map chosen by the liberal Pennsylvania Supreme Court does, I am committed to helping take back the House, holding Pennsylvania's U.S. Senate seat, and electing a conservative Governor. To that end, I am not going to run against another member of Pennsylvania's Republican Congressional Delegation."

"The liberal Pennsylvania Supreme Court did the Commonwealth a great injustice when it once again overstepped its authority and selected a partisan map favoring Democrats. Make no mistake, this map—submitted by a national Democrat group—intends to diminish the voices of conservative voters in central and northeast Pennsylvania. As I said last week, I am not going to let that happen."

"I have always promised to take the values of the people I represent to government. Those values include God, family, country, hard work and honesty. My lifetime of work has reflected that."

"My team and I will continue to work to provide the constituents of Pennsylvania's 12th Congressional District with the highest level of service. Representing the values of the outstanding people of central and northeast Pennsylvania, who go to work every day and get the job done, has been the privilege of a lifetime. Thank you to everyone who has allowed me to do it."

It was a Sunday afternoon in early September when dad said, "Jimmy, would you like to come along with me; I'm going up the river and get some Hellgrammites." He and Max were going fishing on Wednesday and dad said he would get bait. "Wow! You bet," I said. We had always gotten Hellgies by the island just above our house but it was getting played out from hunting them there all summer.

Getting out of the house on a Sunday would be great as mom was pretty strict about what we kids could do on a Sunday afternoon. It was to be a day of rest and quiet time but I had just learned in Sunday School that morning that Jesus picked fishermen to be his helpers. Dad and I were fisherman so mom must have thought that getting bait was an acceptable Sunday activity.

Dad grabbed the new hellgie screen he had made this summer and I grabbed the garden hoe. Dad's Hellgie screen was a wooden frame 4 ft. long and 3 ft. high with the front covered with 1/8 inch mesh wire screen. Hellgrammites live under rocks in the river where there is fast current. When we found the right spot we would pull the boat up on the shore, walk out into about 2 feet of water, find the right group of rocks and I would place the hellgie screen about a foot below the rocks. Dad would now, take the hoe and walk upstream from the rocks and vigorously rake the rocks loose from the bottom with the hoe. The dislodged hellgrammites would drift downstream and grab onto our screen. When he was done raking, he would walk down, pick up the bottom of the screen and we would see what we got.

Dad and I continued up the river, past the train bridge, now on the outside of Blackmans Island, then dad pulled the boat into shore about 50 yards below the eel walls. The river was at low flow and looking upstream there were three giant V shaped rock walls damming up the water, extending from the West shoreline out just past the halfway point of the river. This was where the Gemberling's, Kinney's and Simcox's fished eels. Dad and I got three dozen hellgrammites in no time at all, that was plenty for him and Max to fish with on Wednesday.

Tied up along the shore of Blackmans Island were three eel baskets that would be set at their respective eel wall in the next few weeks. I asked dad if we could walk up the shoreline so I could see one of the baskets up close. The first one we came to was marked Zane and Bill Simcox. This appeared to be framed with 4x4 inch lumber with the sides made of 1x6 inch rough cut pine boards. The overall dimensions were 8 feet wide, 14 feet long, and about 8 feet high to the top of the back boards. If you picture a water ski jump with the ramp built like steps. The steps were built

with wooden slats spaced about 1 inch apart which allowed the water to rush thru the eel basket trapping anything that came down the mouth of the V.

Eels migrated downstream in mid-October on the dark of the moon and always at night. This required the eel basket to be manned all night long. The tender would arrive before dark to clean any trash from the basket and open the trap door at whatever level step he was operating from. The purpose of the step construction was to allow for changes in the river level. His boat would be located right under the trap door so any eels caught could be pushed into the trap door and they would fall into his boat.

As the eel run (migration) began the tender would stand on the step above the waterline, he had a headlamp and a rake with wooden prongs. When an eel hit the slats it would roll allowing the tender to see its belly flash in the light of his headlamp, he would rake the eel up the steps to where he was standing and out the trap door into his boat. The tender did this all night long raking eels to one side of the basket and any trash fish out the other side and back into the river. I was told that if a walleye was caught in the basket it often found its way into the boat with the eels as walleyes were fine fare for the tender's table.

This is the story of fishin eels where eel weirs are not weirs at all but eel walls, where eel baskets have nothing to do with baskets and fishin eels has nothing to do with a hook and line. In 1953, a late October hurricane brought the river up rapidly and destroyed the eel baskets that had been in place. That was the last year of fishin eels on the Isle of Que. Thank God I was privileged to have witnessed this part of Isle of Que history.

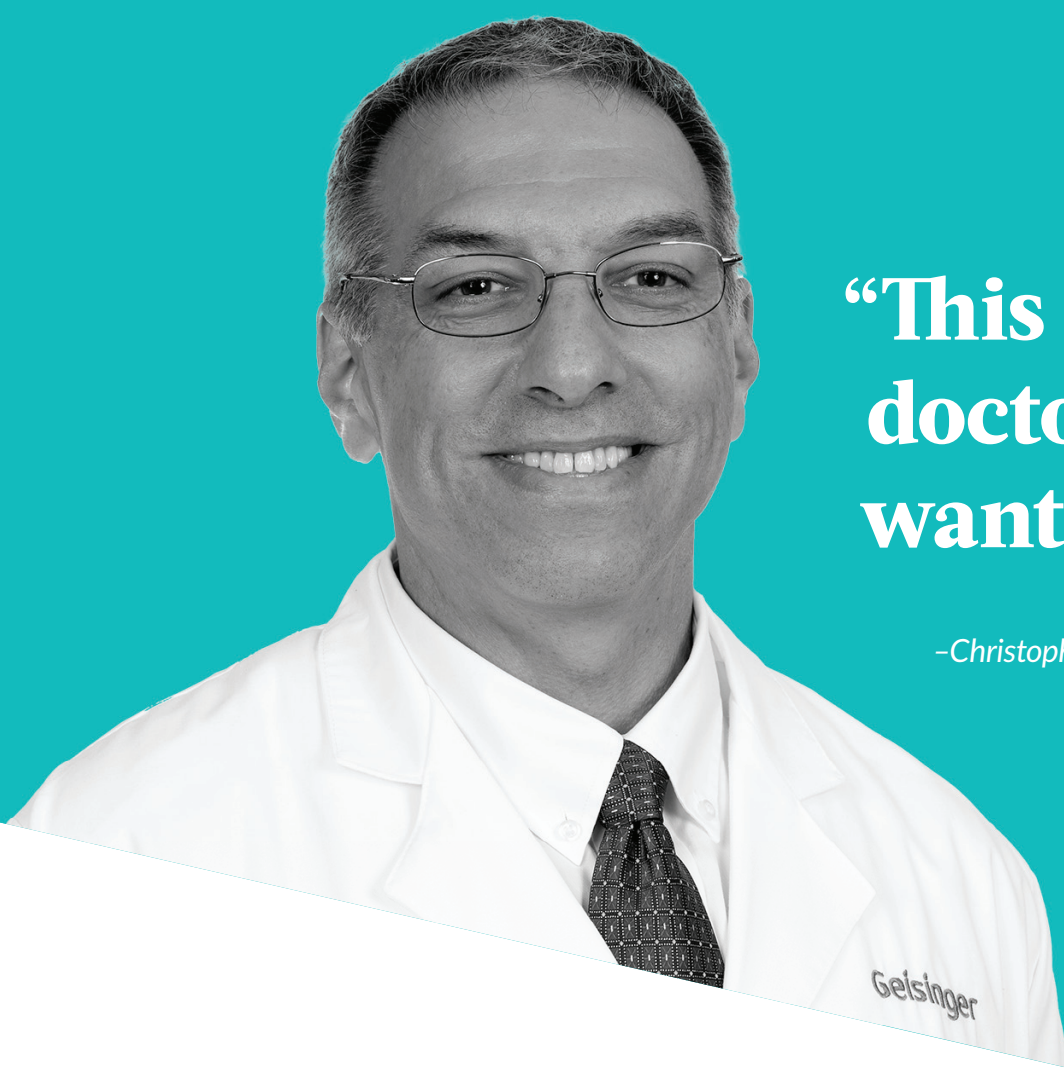
