



Introduction of the New Education Column

The Snyder & Union County Times are pleased to announce the addition of a new column. The column will deal with education, more specifically, learning and schooling. Parents, school staff and community members should have a particular interest. Dr. Joseph Cohen will author these insightful articles.

Dr. Cohen has been involved in education, training, and workforce development activities since 1968. Having begun his career as a teacher in the Philadelphia schools, he moved abroad to teach, be a principal and then a manager of eight American schools in Indonesia, Bangladesh, Brazil, Venezuela, and South Africa. He has worked in a total of 36 countries.

Our first article will deal with the differences between learning, schooling and education. This will be followed by other topics directly linked to achieving a clear understanding of what and how we learn, and defining quality learning that should be the goals of all schools. Later articles will examine what goes on in the classroom and the school; techniques used in quality schools; the engagement of parents and community; the role of the principal; and analysis of issues related to all parts of the education system from the school district, state education department; school labor unions; and the United States Department of Education.

Learning and Schooling – Not Education

You've probably seen the headlines or heard the news. Student standardized tests scores continue to drop. Teachers are leaving the profession due to the threat of violence causing a major shortage. Parents storm school board meeting over sex education in the primary grades. The State Department of Education introduces a new curriculum focusing on important social issues such as diversity, equity and inclusion forcing schools to take time away from core subjects. Music and art programs as well as after-school actives are being cut due to lack of fund-

Is education in America beginning to undermine the very foundation of our democratic system? Can students succeed in the real world after leaving school? It may not be that bad. America has produced the most Noble Peace Prize winners. We have generated more copyrighted inventions that any other country. Many people want to live in America because of the opportunities we offer. So maybe it's not as bad as we think.


It's really not possible to determine good or bad until we understand what it is. To do that let's look at an archery target. Think of the bullseye and the circles as parts of the education system. The bullseye is the archer's goal and in education the goal is to ensure that kids learn. This is the only reason an education system exists. Without the learners everyone would be out of a job. In 2021-22 were 49,356,954 students enrolle schools.

The circle next to the bullseye represents the parents who have responsibility for offsprings until they no longer have influence over them. The next circle represents the teachers who are directly responsible for seeing that learning takes place. The following circle represent the principal whose most important responsibility is to support, evaluate and provide for the professional development of teachers. In 2021-22 there were 98,609 public schools across all 50 states.

From here on out those in the outer circles have only indirect impact on learning while those within the school have direct impact. The next is the school district represented by the superintendent and the school board. In 2021-22 there were 19,254 districts across the USA.

The next circle is represented by the state education system. The Constitution of the United States signed in 1789, specifies that any government service not mentioned is the responsibility of the state. This means there are 50 state systems of education with full responsibility to govern all 19,254 school systems. The federal government is the last circle and will be discussed later The school community can play an important part in

supporting schools and districts, but communities are treated differently. This is because while some schools welcome and are linked with their communities, other schools are closed to serious engagement with schools. Our focus needs to be on what and how students learn. In future articles we will address learning and schooling and answer such questions as: What should learners be learning; How do we learn; What is the difference between quantity and quality learning; what conditions are needed to achieve quality learning and, how can we measure learning?

A River Rat's Ramblings: March 1955 Spring Migration

We had a late February thaw that melted all the snow and caused the ice on the river to break up and leave. The second week of March it got cold again but only formed what dad called slush ice on the river. In the morning the ice would be flowing all the way across the river but later in the day the March winds would pick up and howl out of the west driving the ice tight against the Eastern shoreline. As the of the setting sun reflected off the compacted ice flow, it would glisten like a Billion Waterford Crystals flowing down the opposite side of the river. Dad would say, "Even a poor man gets to be rich when you live by the river." A statement as true today as it was 69 years ago.

One evening before supper dad, Tim and I were standing on the riverbank when a huge flock of Canada Geese flew over our heads as they skirted the West side of the train bridge. "I guess it must be time," dad said as he referenced that flock of geese heading

Back then, the spring waterfowl migration was more spectacular to watch because the pothole region of Northern Canada was still frozen solid. Thousands of ducks, geese and swans raft on the open water of the Susquehanna feeding and resting on their way north. The migration lasted into the early days of April with swans and some diving ducks bringing up the rear as their nesting grounds are in the northern extremes of Canada.

Unfortunately, the spring migration of waterfowl on the Susquehanna River no longer exists. It lives only in the minds of Old River Rats who stand on the riverbank gazing down river in the spring, hoping to witness one last waterfowl migration that we know will never come again.






