



date was May 12, 1989. Just two days later, on May 14th little Phil was born to Lori and Phil Walter. Baby Phil attended his very first race the following week and can be found in many victory lane photos.

Phil drove his own 410 sprint car between the years of 1985-1990. When the expense of running his own car almost put a stop to his racing career, along came Dan Dietrich, Sr. (Danny and Billy Dietrich's dad). The two worked out a deal with Phil set to drive the red #63 sprinter during the 1991 racing season. The team ran close to 70 races that year at various tracks including Clinton County, Lincoln, Susquehanna (Now BAPS), Hagerstown, Georgetown and Selinsgrove speedways.

The following three years (1992-1994) he drove the Black #55 owned by Gene Jenkins and Scott Mertz. In 1993, the team traveled to 17 tracks in 9 different states. They competed often with the All-Stars and WoO sanctioned 410 races when the Outlaws were competing in PA, NY and Ohio.

When asked what was the highlight of his career he had so many great memories, but winning the 358 Nationals at Selinsgrove Speedway in 2004 was a noteworthy favorite. He was asked by Adam Romig to race his car since Adam injured his back and couldn't drive. At the time Phil didn't have a motor, so, of course he took the opportunity to drive Adam's car. Phil started on the pole and never looked back, scoring a huge win for the local

One of the funniest memories is when he was racing with Lenny Krauthiem. Lenny was starting on the outside pole and Phil was starting on the pole. When weather delayed the race for a week, Phil kept on getting messages on his answering machine. Lenny was joking around and teasing Phil with all types of messages. Well, it back fired on Lenny when they finally raced. Phil admitted to jumping the start and Lenny was nowhere to be found. So the joke was on Lenny" stated Phil.

Even though retired from behind the wheel you can still find Phil Sr spending his Saturday nights at the races by being the crew chief and mentor for young 17 year old Braeden Varner from Mifflintown who this past Friday night had the best finish of his career placing second at Clinton County Speedway.

When asked what the Phil Walter Classic means to him, Phil offered this perspective. "It's a race that many weekly racers that don't have huge sponsors and backing can come race and be competitive. The small bull ring of Clinton County Speedway is a great equalizer" stated Phil. "You don't have to have the most expensive or as fast a motor like you need on the big half-mile tracks. It's a driver's track. We have so many talented drivers out there that can come there and be competitive and show the talent they actually have. With the support of so many people, sponsors, fans, we have been able to give back to these guys for doing what we all love to do and that is race sprint cars" said Phil.

To say the least, the work and effort put in by Phil II and Lori went over and above and the results were appreciated by everyone.



turning singles into doubles and doubles into triples. The Tigers 'XBT' is the highest in the league since the 1975 Oakland A's. If James Franklin does not win this year's college football championship, he will never win one at Penn State! Talk about pressure. This year's team is by far the best one on paper. Per college football guru Phil Steele, Penn State has the top rated units at QB, RB, O-line, D-line, LB and

The Community Giving Foundation has grown to over \$2.5 million in investments,

PA Department of State Introduces Redesigned, User-Friendly Provisional Ballot Envelopes

Continuing the Shapiro Administration's commitment to strengthening our democracy and keeping our elections safe and secure, Secretary of the Commonwealth Al Schmidt announced recenty that the Department of State has redesigned the provisional ballot envelopes that counties use in an effort to improve legibility and make the envelope more user friendly. The redesign aims to decrease the number of rejected provisional ballots, allowing more eligible Pennsylvanians' votes to be counted

'Every registered voter in our Commonwealth should have the opportunity to cast their vote and make their voice heard in each election," Schmidt said during a press conference in Philadelphia. "We believe these changes to the provisional ballot envelopes will have a positive impact, just as the changes we made to mail ballot materials two years ago did.'

This envelope update follows the Shapiro Administration's successful redesign of mail ballot envelopes and materials in 2023. Those redesigned materials resulted in the November 2024 general election seeing a 57% decrease in mail ballot rejections.

In that same election, 29.12% of the provisional ballots cast in Pennsylvania were rejected. The most common reason for a rejected provisional ballot was that the voter was not registered; the second-most-common reason was an incomplete provisional ballot envelope.

The redesigned envelopes feature a layout that clearly instructs voters which fields they must fill out, including highlighting the two places where the envelope must be signed. The envelopes also streamline the process for election workers, identifying which fields they need to complete before and after the voter completes their pro-

The Department received design feedback from county elections officials in Philadelphia, Berks, Butler, Mercer, and Greene counties, who specifically mentioned the need for enhanced usability for voters and poll workers alike. "During this redesign process, we listened to our county election officials who told us the design of the provisional ballot envelopes led to missing signatures and incomplete envelopes, which ultimately led to the ballots being rejected," Schmidt said. "I want to thank the county elec-

tion officials who worked with us in this redesign process, which is another step toward ensuring that Pennsylvania elections remain free, fair, safe, and secure."

The redesign of the ballot envelope simplifies the process of voting provisionally, and that means fewer errors and fewer rejected ballots," said Omar Sabir, Chairman of the Philadelphia City Commissioners. "It's an important part of ensuring that every eligible vote gets counted, and we're proud to lead this multi-county effort alongside our partners at the Department of State.

Schmidt said he expects counties to use the new voterand poll-worker-friendly materials in the 2025 general election. To help counties with the cost of replacing their current provisional ballot envelopes, the Department is offering grant money to counties who opt to use the new envelopes.

County elections officials may ask a voter to vote by provisional ballot under certain conditions. A provisional ballot voter is asked to follow these instructions:

Complete in front of election officials the sections on the provisional ballot envelope labeled Voter Affidavit,

Voter Signature #1, and Voter's Current Address. Mark the provisional ballot in an accessible and private area of the polling place.

Seal the provisional ballot in the secrecy envelope.

Seal the secrecy envelope in the provisional ballot affidavit envelope. Fill out in front of polling place election officials the

Voter Signature #2 section on the provisional ballot en-

Return the sealed provisional ballot affidavit envelope to a polling place election official.

Receive a provisional ballot identification receipt.

Within seven days after the election, county boards of elections decide whether each provisional ballot vote should be counted.



The Snyder County Soldiers and Sailors Memorial is 22x30 feet built of rock granite and granite brick with a reinforced concrete roof. At the top of the front section the words, "Snyder County Soldiers' Memorial" are cut in raised letters in the heavy granite blocks. A number of army corps badges are cut on the east and west ends of the steps leading to the entrance. Two mounted cannons are placed at each side the entrance flanking large wide concrete steps leading up to the Memorial. The cornerstone of the building is imprinted with "Sept. 28, A.D. 1905."The inner room is a sanctuary lined with marble walls dedi-cated to those who served with six memorial stain glass windows. John F. Stetler was the architect and well-known for several homes and buildings in the area.

REC Highlights Expanded After-School Program During State Officials Visit

ing its free drop-in programs for students in grades 3-12 thanks to funding from the Pennsylvania Commission on Crime and Delinquency's (PCCD) BOOST Grant Program. The Building Opportunity through Out-of-School Time (BOOST) Grant Program aims to prevent community violence by providing safe, structured spaces for On July 24, PCCD officials visited the REC to see

BOOST funding in action, engage with youth participants, and discuss the importance of continued investments in out-of-school time programs as a strategy to prevent violence and promote safer, healthier communities. "REC's Drop-In Center gives youth a safe place to

learn, grow, and build relationships—and that's exactly what our BOOST grant program is all about," said PCCD Executive Director Kirsten Kenyon. "We're proud to support local organizations like this one that are opening doors for young people, keeping them safe, and making our communities stronger every day."

Last January, PCCD's School Safety and Security

Committee approved \$11.5 million in first-time BOOST grants to 46 programs across the Commonwealth. The REC received \$167,000 to enhance and expand its free after-school and summer drop-in programs.

During the academic year, the REC's Drop-In Program

served a record 367 youth after school from the hours of 3-6 pm. There are currently 89 youth registered to attend the Summer Drop-In Program, compared to 32 registered last year without PCCD's BOOST funding. Staffing and operational costs being covered by BOOST have allowed for increased hours of operation and unlimited access for youth to attend the Summer Drop-In Program, providing food security, socialization, and educational experiences at no cost until school starts.

"I couldn't be more grateful for the funding and support from PCCD for our free after-school and summer drop-in programs, allowing us to be open all year long," said REC President Kelly Feiler. "This grant funding has allowed us to stay open during university breaks and offer a summer session to far more students than in previous years. We are also developing data collection methods that will improve our ability to show the impact of our programs to the community and state. I know our program participants and staff are equally grateful for PCCD!"

The BOOST initiative is part of the Shapiro-Davis Administration's broader commitment to enhancing community safety and investing in the well-being of youth across the Commonwealth.

Lewistown Awarded Main Street Designation

On July 23, 2025, Governor Josh Shapiro and Department of Community and Economic Development (DCED) Secretary Rick Siger visited downtown Lewistown to announce its new Main Street designation through the Main Street Matters program, which provides downtown business districts with the tools they need to create healthy, vibrant

The new designation will allow Downtown Lewistown, Inc. (DLI) to apply for up to \$225,000 in grant funding to support its five-year revitalization strategy, including efforts to remove blight, improve public spaces, and attract new development. With the recent purchase of the former Bon-Ton building by Geisinger Medical Group for the new Geisinger Medica singer School of Nursing, DLI plans to leverage the Main Street designation to grow the nursing program and attract additional health professionals and medical businesses and opens the door to new growth opportunities for Lewistown

and Mifflin County.

Every community in our Commonwealth- rural, urban, or suburban- has a Main Street, and we know how vital they are to local economies. Our main streets are the beating hearts of towns and cities, and their success is directly tied to the small businesses that line them," said Governor Shapiro.

DCED administers the program, which has built upon the success of the Keystone Communities Program (KCP). DCED has supported downtown Lewistown in the past through KCP façade grants and in 2019, DCED awarded \$142,155 to DLI for a connector project linking West Water Street to the Kish Riverwalk, Victory Park, and Juniata

River Trail.

"With both the Main Street and Enterprise Zone designations now in place, Lewistown and Mifflin County are uniquely positioned for growth and revitalization. I want thenk Covernor Shapiro for his visionary, strategic leadto thank Governor Shapiro for his visionary, strategic leadership- he has created a culture of collaboration between state and local governments that is delivering real impact in communities like ours," said Mifflin County Commissioner Kevin Kodish.

"When Lillah and I opened East End in 2017, we wanted to create more than just a coffee shop. We wanted to invest in our community and reimagine what downtown Lewistown could be," said Ryan Cherry, owner of East End Coffee Co. "Since then, East End has become a space for live music, art, yoga, great food, and even better conversations. We've partnered with neighbors and built something that reflects the heart of this town. Lewistown has so much potential, and I'm proud that the state sees that too and is stepping up

to support our downtown's growth."

"The work we do is about creating real places — where kids can grow up, seniors can grow old, and families can put down roots," said Julie Fitzpatrick, Executive Director, PA Downtown Center. A Little League World Series Experience

liamsport, Pennsylvania and with it hundreds of ten- to twelve-year-olds hoping to experience the baseball season of their lives. All of these kids are already champions, winning in their local area, then districts, then states, then regional tournaments just to get here. They've been on the road all summer long.

When players first arrive, they go through what they call the "car wash," but it's not the typical fundraiser type of car wash you may think of. It' smore like a fast-track way to get to know who these young players are. They take headshots, gather roster information, film video features, and distribute equipment and uniforms to the teams. Think of it as a Little League media day. It also gives players the opportunity to meet and bond with their opponents in a fun setting. They try food from each other's countries and just enjoy the experience together. Then, they get ready for some baseball.

Many people around the world only dream of attending, but for those who live in this area, it should be a must-do on your summer bucket list as it is a free family-friendly event. The games will take place between August 13th 24th and will be played at either Howard J. Lamade Stadium or Volunteer Stadium, both in the Little League International Complex. To top it off, this year's Little League World Series Classic will be an intense matchup between the Seattle Mariners and the New York Mets.

Two summers ago, I got this crazy idea that I wanted to work at the Little League World Series, much to my family's displeasure, but I'm someone who is all about experiences and wanted to do it anyway. It was only going to be a little over two weeks of me working long days in hot temperatures and getting only a few hours of sleep each night. Sounds fun, right?

Well, it really was! Don't get me wrong though. There were some bad times, but overall, I'm so glad I got the full Little League World Series experience. I didn't do anything spectacular. I signed up to work in the concession stand which was an experience in itself. It felt like what I think it would be like to work in a fast-food restaurant. It was a busy place. It included those who volunteered in the concession stand in order to earn money for their school or organization. It included staff of Little League International who had to volunteer doing something during the Little League World Series, and it included people like me who were hired by a company called Delaware North who staffs concession stands at stadiums, large concert venues, and events. The head boss of the concession stand was actually the guy who runs concessions for the Cincinnati Reds. His name was Nick, and he was young and kind guy.

Each weekday, I would get up and go to my full-time job and then drive directly to the huge field parking lot across from the stadium and make my trek up the hill to the concession stand. It took about 15 minutes to make that walk each day in and each day out, and it felt like it got hotter each day I walked it. I would work my butt off each shift I worked, drive 45 minutes home arriving at nearly 11:00 p.m., wind down, and then get up to do it all again the next day. It was exhausting, but still worth

hopes to write an article about my full Little League World Series experience, and by day 3, that went out the window. I just didn't have it in me to do so anymore. That's not to say I didn't mentally have it in my head, but writing each night on top of the days I was having just

Here are a couple excerpts from Day 1 and Day 2 journaling.

It's here!! First official day of games. Got to work at 8:30 a.m. Then, got to the Stadium around 1:25 p.m. Then I took the dreaded uphill walk to the concession stand where I signed myself up to work for the next two weeks. The stand was busy upon arrival. I got right to work. I was directed to a station helping prepare food. The usual hot dogs, burgers, etc. I was working with a guy named Donnie. He reminded me of the "NO RAGRETS" guy from We're the Millers. A new woman came to work with me named Joanna. We were like two peas in a pod. We talked and got to know each other and we're a great team. A few hours later, I glanced at her badge, and I saw Joiner on her badge. I was like, "do we have the same last name," and we did. Even more, we are both JJ names. Joanna Joiner. My sister from another Mister. We finished shutting down our area, cleaned it, and I left for the night. As soon as I was heading out the door, the last game was letting everyone out. It was a crowded walk out of the stadium to an even more crowded parking lot. I got in my car and sat in complete gridlock for 45 minutes before I got to move forward. It took forever. Called my husband while I waited and gave him the summary of my day. Finally got to drive and got home at 10:57 p.m. Other noteworthy events of the night were making some new friends from Mifflinburg, Meg and Josh Owens, and getting to see an old friend, Scott Frost, who was also working there in a security position. Overall, it was a good first official day. I'm tired and was very sweaty and hot all day.

didn't pee until I got home. Day 2 I arrived at the stadium around 4:25 p.m. I got sent to make pretzels to cover someone's break. It was okay, but not my favorite. Either way, I immerse myself in learning

P.S. I drank five bottles of water and one Gatorade and

to bake the pretzels and going out to put them in pretzel warmers and finding the old ones to throw away. I feel professional at this task now. They say it's time to not bake anymore, and I wander to find where I can help next. Someone needed peppers and onions, and there were none in the hotboxes, so I cooked some up. A guy

named Ryan asked me if I would help Miss Laureen with dishes, and I happily obliged. I learned to use a commercial dish washer which I have never done before. After the dishes were done, I ventured back into the concession stand looking for something to do. I found a girl making pizzas, and that was something I haven't done before so I asked her to show me what she does to make them. I made my first pepperoni pizza, and my pizza looked pretty damn fine if I may say so myself. I left about half an hour early due to the lack of work, and as soon as I started the full 15-minute walk to my car, it started to rain. Lovely. Two minutes into my drive and it started to rain heavily. It was the white knuckle, people putting their hazards on, and Florida afternoon-style torrential downpour for the next 20 minutes. I arrived home and indulged in some I.C. Mango Light beers topped off with a Miller

Lite. Overall, good day.

Tired. My back hurts but tomorrow is a new day. See you on the flip side. 12:36 a.m. Jamiee"

The thoughts went on in my head like this as I drove home each night, but they never made it to paper after the first two nights when the exhaustion started to set in. I'm okay with it though. I met some really nice people who work for the Delaware North Company who are mainly out of the Cincinnati, Ohio area but travel to large events to do this type of work all the time. I do like to travel, so it could be fun, but then again, you really don't have any downtime to explore the area you are working in.

For me, the experiences are partly the people you encounter along the way. Some were awesome. Some not so much. Some stopped showing up after the first day or the first three days, and some stood out above the rest jumping in where they needed to make it all work. Ryan was chill, a team player, and he travelled from Philadelphia each year to work at this event. Miss Laureen was pleasant, kind, and a hard worker as well. Both her and Ryan were true leaders in their roles. James and Nick were really great too.

One night, while walking into the stadium, Team California was right behind me on their way to play the championship game which they ended up winning, 6-5 over Curacao. I can honestly say that every time I walked into the stadium, the excitement was palpable. I would see teams from other countries practicing, players crying, proud parents cheering on their kids, and little leaguers from all over the world living out their baseball dreams right here in Central Pennsylvania.

What made me decide to work there was that, at the time, we had lived in this area for twelve years, and we had never been to a Little League World Series game, never witnessed the big hill that the kids slide down on cardboard boxes, and never knew what we're missing out on. I also can proudly say that by the end of the two plus weeks, I had aced every concession stand task. So, if you have a young kid, or are a kid at heart yourself and you want to experience watching America's pastime, go to a game. You won't regret it, or maybe you will after trying to leave the parking lot after a game. Either way, I suggest you go.

If you are unable to attend any of the games, you can watch them on ESPN+, ESPN, or ESPN2. The championship game will air on ABC, or you can stream it on

Middleburg Received Traffic Light Upgrade

Middleburg has reached the big times with the recent traffic light upgrade at the center of town! For local residents the traffic light definitely has all the bells and whistles! No one can claim successfully that they didn't see the "red

The one and only traffic signal in Middleburg is located at the intersection of SR 522 (Market Street) and SR 104 (Main Street) in Middleburg Borough.

Why did Middleburg need such a massive traffic light overhaul? According to Elizabeth Page, Borough Administrator/Zoning Officer, the "old traffic signal is an old-style signal which operates on a timing loop control system and was last modified in 2002. PennDOT has been working with the Borough to update the traffic signal to a modernized overhead detection system, which will allow for traffic to flow more efficiently." In 2005 poles were replaced at

Josephine R. Beaver, PennDOT Senior Civil Engineer Supervisor, concurred. "This is a typical traffic signal modernization/replacement project that is locally administered by the Borough of Middleburg, which was funded through the Green Light Go (GLG) Program. The existing traffic signals... operated in a pre-time mode with antiquated components that are difficult to maintain."

The Borough obtained a Green Light Go (GLG)grant to update/replace the traffic signal. The grant covers 80%

of the cost and the Borough is responsible to cover the remaining 20% of the grant. The total grant awarded was \$478,452.25.

Installed by PennDOT, the traffic signal project is in its final stages. The traffic signal control system needs to be certified by PPL and PennDOT before the traffic signal is placed into the new overhead detection mode.
Page notes, "Currently,

the new traffic signal is still functioning in the old timing loop mode .Once the new traffic signal is certified and approved, traffic should flow more efficiently through the intersection."The new signals will be fully operational after the activation on Thursday, August 14, 2025.

Once the certification and approval processes are completed, the Borough will responsible for maintenance and

According to Beaver, "This project will bring the intersection up to the current standards including new traffic signal poles, mast arms, signal heads and controller cabinet. The new signal installation also included timing changes, vehicular detection cameras, ADA pedestrian accommoda-tions and emergency preemption." Then she added, "The new traffic signals will improve the movements of both vehicular and pedestrian traffic. The new equipment will reduce maintenance cost while the installation of pedestrian signal heads and push buttons will improve pedestrian safety at this intersection."

"I am glad to see investment put into this ever-busier intersection. I only hope that the proximity of the posts to the corners does not cause any problems in the future,' said Snyder County Commissioner Joe Kantz. "I continue to share thoughts with PennDOT about how we might continue to improve traffic flow through Middleburg and I appreciate their willingness to explore those ideas.
