## Bread Of Life Food Ministry Provides Christmas Meals

The Middleburg law firm AxRunkle, PC in Middleburg and the Runkle Agency, LCC, an independent insurance agency in Mifflinburg generously supplied the Bread of Life Food Ministry with all the hams needed for each of the 79 families for their Christmas meal. Rick Maloyed of Beaver Valley Country Store arranged the quick delivery of the hams.



As her Gold Star Girl Scout Project, Hannah Shriver has implemented the Bread of Life Food Ministry held at Paxtonville United Methodist Church. Since March 2021, it has served a total of 157 (676 people).

Last fall, Hannah Shriver, a senior at Midd-West, began designing Bread of Life Food Ministry for her Gold Award. The Gold Award is the highest award a Girl Scout can earn. "I've been in Girl Scouts for 11 years and it was something I really wanted to do. It was last October that I had the idea to start a Food Ministry," explains Hannah. "It was something that God had really put on my heart. That's why I named it Bread of Life Food Ministry. I wanted it to be a way to support my local community but also spread the love of Jesus."

There were many components to creating a Food Ministry including a place to hold it and a way to obtain food donation. Paxtonville United Methodist Church stepped up and offered an area to store the food and a place to hold the distribution at the church.

Hannah faced several challenges. First, was reaching families that needed help. She uses a registration and distribution procedure. "Being a very small Ministry we don't have an endless supply of food so we want to make sure we can provide everyone with food." The first Bread of Life Food Ministry distribution was held in March 2021 with 12 families participating.

Another challenge was obtaining donations to fund the ministry. "There were several moments where I thought this wasn't going to happen," says Hannah. "But despite my doubt, God provided for the ministry."

Eventually, the donations started coming in. "People were so generous with their donations, I had more food than I knew what to do with."

However, as the months went on the supply began to dwindle. "I was little worried that we wouldn't have enough to continue, but every time I had a little doubt God was always there providing for the Ministry. It's been really amazing watching God provide for his people. His faithfulness is truly awesome," notes Hannah.

Hannah and her team of volunteers work together to make this ministry so successful. Her family and friends have been supportive of her project. The youth group at Paxtonville UMC has also been incredible. "I don't even need to ask them for help, they just show up and start helping."

The planning is ongoing. There is really a lot of behind the scenes work that goes into the distribution each month. Each month after the registration period Hannah and her team decide what food is going to be distributed on the number of requests and people to be served. "We either go shopping or collect donations to get all the food. We spend an evening packing up all the boxes for the families. Saturday mornings we will go get fresh produce and set up the distribution. The families drive up to the back door and we load everything into their cars for them."

Approximately 32 families participated in the November Thanksgiving food distribution. For December Hannah wanted to do a complete Christmas meal for all the families to include stuffing, mashed potatoes, veggies, and a ham for each family. "But when registration was closed and I realized we had almost 80 families, I figured that it probably wouldn't be possible to be able to give everyone hams."

However, the Middleburg law firm AxRunkle, PC in Middleburg and the Runkle Agency, LCC, an independent insurance agency in Mifflinburg generously supplied the Bread of Life Food Ministry with all the hams needed for each of the 79 families serving 345 people. Jeremiah Runkle, owner of both businesses, said "We've been incredibly blessed this year by the patronage of our community and are pleased to share with those in our community facing difficult times."

Rick Maloyed, manager/co-owner at Beaver Valley Country Store also assisted by arranging for the delivery of the hams on short notice. The distribution was held on December 18.

"It was just really wonderful, it brought me to tears. The generosity of this community is just amazing, I had so many people reach out to me and ask if I needed anything else," says Hannah with heartfelt emotion. "I feel incredibly blessed that we are able to help so many local families have a good Christmas."

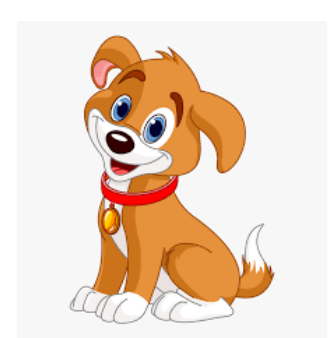

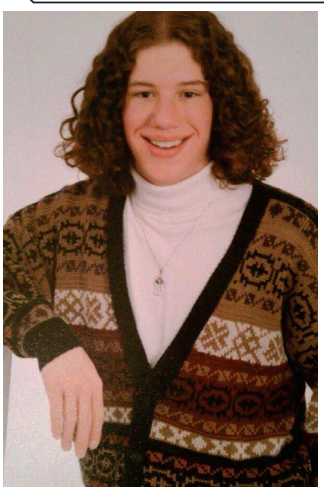
# Kelsey's Dream Creates Special Program

## Evangelical Awards DAISY Honor to Anne Griffin, RN, MSN

Anne Griffin, RN, MSN, was presented the DAISY Award on Tuesday, November 9, 2021. The award is presented to a deserving nurse who exemplifies clinical expertise and compassionate care and is recognized as a role model in the nursing community.

Griffin was surrounded by her fellow coworkers and mentors, as well as Hospital and Nursing leadership, as she was presented with the award. She was nominated for the award by Nicole Bingaman—the mother of a patient at one of the COVID-19 vaccination clinics in April 2021—who was present with her son to honor Griffin with the award.

In the nomination, Bingaman shared, "I attended my son's (who is an adult with cognitive impairments due to a brain injury) COVID vaccination with him. The process was all a bit overwhelming and he was feeling stressed out. Both times Anne was the nurse giving the shots. She was super friendly, relaxed, and made my son feel at ease. She did not treat him any differently as a 30-year-old disabled man than she would anyone else. He joked with her, she joked back. We both felt like she was a friend and was most certainly the kindest part of the process."

Bingaman continued, "When someone is 'different,' people around often react. This was a challenging day for us. Masks, COVID, etc., has been very stressful for my son. He does not always keep his opinions in-check due to frontal lobe issues. Anne acted with such kindness and warmth. It is the little things that matter most."

Griffin has a long history at Evangelical, beginning in October 2000 as a member of the PRN nursing pool. In January 2005, she began in Pediatrics where she served until she transferred to the Emergency Department in December 2010. In September 2020, Griffin began serving at the Ambulatory Surgical Center. Becoming "semi-retired" in October 2021, Griffin continues to be an active per diem employee serving patients through the COVID-19 vaccination clinics.

The DAISY Foundation was established in 1999 in California by the family of J. Patrick Barnes, who died at the age of 33 from complications of an auto-immune disease. During his eight-week hospital stay, his family was impressed by the care and compassion his nurses provided, not only to him but to everyone in the family. They created the DAISY Award in his memory to recognize those nurses who make a big difference in the lives of so many people.

Evangelical is proud to be a DAISY Award partner. Nurses are nominated by patients, family members of patients, as well as other healthcare professionals. Nominations are presented for consideration through a process of anonymity. The winner is then selected by a board of healthcare workers. Today we all went over town in our 1949 Willis sedan and bought a tree from the Boy Scouts. We brought it home and spent the evening decorating the tree, eating cookies, and listening to the girls play Christmas Carols on the piano. Dad always set up a full size wind up train under the tree and we thought it was wonderful. There was something very special about having the Christmas tree up, after supper we would sit in the living room with only the Christmas tree lit, listen to the radio and talk with each other. It was a quieter time then with a lot less distractions.

Finally, it was the last day of school, tomorrow is Christmas Eve and then no school for ten days. Christmas Eve day was very tough for a six year old and even harder for a four year old. Tim and I would go outside to play but the two inches of snow was hard and crusty and no fun. Dad got home from work, he took Tim and I for a walk up along the river to the train bridge where we could throw stones into the river.

When we got home it was almost dark and supper was almost ready. Dad attempted to read the paper while the four of us took turns being a barber and would pretend to cut and style his hair. "Suppers ready," mom called from the kitchen. We all sat down at the kitchen table, said grace and enjoyed mom's meat loaf with creamed potatoes, peas and applesauce. We all helped clean up the dishes because at 7 pm our Pink Grandma and Grandpa would be down from Lewisburg with their Christmas gifts for us to open.

They were always fun to visit with and Christmas Eve was even more so. (I'll explain Pink Grandma and Grandpa in another story.) They brought several gifts for each of us but Tim and I each got a Davey Crockett outfit complete with rifle and coonskin cap. Tim used his rubber Bowie Knife to fight until he threw it at one and broke a ball on the Christmas tree. Fightin stopped until we could go outside to play. The girls got dolls, clothes, and books. We had a fun evening and by 9 pm they were on their way home and us kids up to bed.

Carolyn was always the first one up on Christmas morning, she would go down stairs to see if Santa was there. She never opened a gift, then would go upstairs and quietly wake Linda, then mom and dad. I think they all knew that when Tim and I got up the peace and quiet of Christmas morning would come to an end. Mom went down and put coffee on for her and dad then told the girls to wake Tim and I.

"It's Christmas Morning Brother", I said almost pushing him out of the bed trying to shake him awake. Mom said, "You boys have to brush your teeth before you can come down." I don't know if our tooth brushes touched our teeth because we almost passed our sisters going down the steps. Mom and Dad were in the living room with their coffee, now we had to wait for the girls before we could open presents. Santa had arranged the gifts in piles, each of us having our own pile. Tim was the first to open a gift, a pair of socks; he had not yet learned to save the soft presents until last. He and I both had a gift that was about three feet high so we both ripped them open. WOW, I was looking at a genuine Hoppa Loang Casidy outfit and Tim was looking at a Roy Rogers Jr. outfit. They had hats, two six guns with holsters, shirts with fringes and real cowboy boots. Right over our pajamas we were instantly transformed into heroes of the old west.

Mom got us focused on Christmas once more. I got a pair of binoculars, a new rod and reel, some army men and books and clothes. Tim got a dump truck, bulldozer, a set of cowboys and Indians as well as some books and clothes. The only thing I remember the girls getting was a portable record player and some records which they immediately plugged in and to this day I'm haunted by Patti Page singing, "How much is that Doggie in the Window?" over and over again.

Later on Christmas day we went over to our Grandma and Grandpa Rishell's house for dinner. They lived over town at 500 W. Pine St. and our cousins Dave and George Rishell lived one block farther West on Pine St. We always had a good time but we had to wear church clothes to Christmas Dinner and I was always glad to get back to our home on the Isle of Que. Little did I know in 1952 that the feeling of coming home to the Isle of Que would last a lifetime.

## Tis The Season For Holiday Scams

The Pennsylvania Department of Banking and Securities and the Pennsylvania State Police (PSP) are reminding consumers to be vigilant against fraud and scams associated with holiday shopping. Five common scams to watch out for this season include:

1. Hacked Account Scam – A scammer may use technology to make it seem like your financial institution is calling you to inform you that your card or account has been compromised. They may have details like the last four numbers of your card or listing of recent purchases. This is an attempt to establish credibility and create an urgency to prevent additional fraudulent activity, while seeking additional sensitive financial information. Your financial institution will not call you unsolicited and ask for details such as your Social Security number, account or credit card numbers, or password. Always contact your financial institution directly using the phone number from your statement, bank card or their website to verify any calls from the institution.

2. Unbelievable Price on Hard-to-Find Items – Everyone enjoys a bargain, but if the item you're looking to purchase is showing for significantly less than compared to every major retailer, it is likely fraudulent. The scammer will try to sell you a plausible, but ultimately fictional, reason for the price difference. Fraudsters will tell you there are multiple people interested, but they'll let you buy it if you send payment immediately. Once you send the money, you'll receive bogus shipping information or never hear from them.

3. Bank Deposit Holiday Hustles – Having your checking or savings account information used for depositing mystery shopper checks or other deposits whose funds you don't know the source of can lead to financial loss and difficulty reestablishing banking services. When you endorse or sign a check, you are vouching for the legitimacy of those funds being available. A scam artist may send you a check for an amount to buy certain items to send somewhere, allowing you to keep a portion for yourself. If that check or funds are fraudulent, you will be liable for the entire balance.

4. Copycat Websites – Identity theft can occur despite taking precautions. Consumers can help reduce the chance of having their personal or financial information stolen by practicing safe online shopping. Malicious emails can appear to be from legitimate retail stores. Do not click on these links. Instead, bookmark the URL for your favorite stores to ensure you are accessing the appropriate site. If purchasing items online, be sure to monitor your accounts after for fraudulent or unauthorized charges.

5. Gift Cards – Gift cards can be a versatile and practical holiday gift but remember that no government agency will ever ask you to pay a fine, fee or penalty with a gift card. If you receive a call telling you to pay a debt or some other cost via gift card, that is a red flag of a scam. Hang up immediately. Once a scammer has the codes and pins from a gift card, it is extremely difficult to recover any funds.

Pennsylvanians who have fallen victim to a scam can contact their financial institution and local police department through non-emergency channels. Additionally, victims can file a complaint with the FBI Internet Crime Complaint Center.

In addition, the free "See Something, Send Something" smartphone application enables people to report suspicious activity. Consumers are encouraged to capture photographs, screenshot and other information and send directly to the PSP. Tips can also be sent to [tips@pa.go](mailto:tips@pa.go)
