### Reclamation Project Starts Next Week on Smalsh Barrick Road in Snyder County

Motorists are advised that lane restrictions begin next week on Smalsh Barrick Road in Middlecreek and Jackson townships, Snyder County, for a reclamation and paving project.

Starting on Monday, June 9, 2025, a Pennsylvania Department of Transportation (PennDOT) maintenance crew will perform a reclamation on Smalsh Barrick Road between Route 522 and the New Berlin Highway (Route 1005). Motorists can expect single lane conditions with flagging where work is being performed. Work will be performed between the hours of 6:00 am and 3:00 pm, weather permitting. Reclamation is a process used to mill, crush, and add emulsion to the existing roadway material. The material is then conveyed into a paver, placed on the roadway and compacted to restore the roadway section and profile. Motorists should be alert, slow down, expect delays in travel, and drive with caution through the work zone.

I reported last week that the sky isn't falling on the Phillies. The sky was awfully low in Pittsburgh last weekend with all the rain and the Pirates sweeping three games from the Phils. Their run production is running pretty low as well. Bryce Harper means more to their offense than we previously thought.

The Steeler fans nightmare finally came true as I have been saying since January. Aaron Rodgers is officially a member of the Pittsburgh Steelers. No one can tell me that Rodgers isn't a better quarterback than Mason Rudolph. People don't like his attitude, age and fascination with ayahuasca. Rodger's first step to win the fans over would be to toss the football with Paul Skenes in the outfield as Skenes warms up before a start.

I can't see the Steelers going far in the postseason or even making the playoffs with Rodgers as their QB. He will win more games than Rudolph but that's the rub. Pittsburgh will win enough games to be slotted in their normal 18th to 22nd pick in next year's NFL draft. If Rudolph was the QB they would have a top ten pick in a quarterback-rich draft.

The New York Knicks continue to take one step forward and two steps back. Firing coach Tom Thibodeau after he led the Knicks to the Eastern Conference Finals for the first time in 25 years was a terrible move. Owner James Dolan loves star power and not the blue collar, lunch pail carrying coach that Thibs is. Dolan once had Isiah Thomas as his GM/head coach!

If you had a chance to watch any of the French Open tennis finals match last weekend you were treated to competition at its highest level. #2 seed Carlos Alcaraz was trailing #1 seed Jannik Sinner triple championship point at 3-5, 0-40 in the fourth set. That was the beginning of Alcaraz's unprecedented, preposterous comeback as he completely turned the match around.

The US Open golf championship is currently being played at Oakmont CC outside Pittsburgh. Scottie Scheffler is the favorite and ranked the best golfer in the world. Is he really the best? LIV golf has watered down the quality of PGA fields. LIV players such as Brooks Koepka, Bryson DeChambeau and Jon Rahm are very good and will validate just how good Scheffler is.

If you listen to what Ohio State fans are advocating for penalties to the Michigan football program you have to laugh. They include vacating all wins over the last five years and their national title. Losing 30 scholarships for three years and banning Jim Harbaugh from ever entering the state of Michigan again! They are even calling them "that team to the south" because now Michigan will forever reside beneath them. It's going to be interesting to see what the actual penalties will be.

In last week's article I mentioned changes in college sports need some guide rails. It appears the NCAA settlement of the antitrust suit against them last week is a start. The NCAA has agreed to directly pay athletes and provides back pay to former athletes. It includes paying \$2.8 billion to athletes who played between 2016 and 2024. Payments will be issued over ten years and most of the money will come from the NCAA.

Power 4 conference schools (ACC, Big 10, Big 12 and SEC) will be able to share up to \$20.5 million in revenue with their athletes, with this amount increasing in future years. Other Division 1 institutions can choose to participate or not. No school is required to pay a dime to any player and just add it to their bottom line. Competition for players will require the big schools to get into a bidding war. This \$20.5M is basically a salary cap.

The benefit of this revenue sharing is that schools can have contracts with athletes and limit the number of transfers. There will be a buyout of the contracts and if another school pays that buyout that money goes against the new school's cap. There is no rule for a contract but schools will push them for consistent rosters year to year.

Athletes can still negotiate external NIL deals, but those worth \$600 or more will be subject to scrutiny to ensure they are at fair market value. It will no longer be 'pay to play.'

What all of this means is that schools will be eliminating sports that cost too much money. The big explosion in women's basketball and softball will be curtailed due to return on investment. Olympic sports are also going to suffer for the same reason. I also foresee chaos and a lot of separation between athletic departments and school administrators.

It remains to be seen what happens to the smaller men's basketball schools like Fordham and Butler. The days of a non-Power 4 school making a deep run into March Madness will be limited. Talent on the gridiron at P4 schools will be spread out with the salary cap creating some parity.

In a related story ...Penn State is one of the first schools to sign a capital deal with a private equity firm. The College Investment Initiative is funded by the sports consulting firm Elevate. The total amount is reported to be in the eight-figures. Penn State AD Pat Craft is still denying any deal. Stay tuned for more to come.

District 4 LAX teams have now lost their last 20 games in state competition dating back to 2015. Both the Grove boys and Lewisburg girls lost their first round games. Different areas of the state each have their winning reputation in various sports.

D4 wrestling has traditionally been a power in PA along with the Allentown area. District 12 (Philly) in basketball, D3 and 7 (Allentown and Pittsburgh burbs) for baseball. Allentown and Harrisburg area for field hockey and Pittsburgh for football.

Congratulations to Lewisburg's Landen Wagner (outfielder) and Mifflinburg's Cole Reibsome (pitcher) being named Heartland conference first team All-Stars. Midd-West infielder Braxton Smith and Wagner were also named first team District 4 All-Stars.

Athletes are not the only profession to not honour signed contracts. Shikellamy superintendent Jason Bendle is heading to Berwick with more than two years remaining on his contract. He left Danville for Shik after serving only 14 months of a five year contract. Do we want these types of people educating our youth?

It's been one month since Don Kelly took over as manager for the Pirates. His record is 15-14 and he already received a contract extension. Is there hope? Shadeur Sanders will be the Browns starting QB by Columbus day. ## Consolidate & Expand

Now that Penn State has announced that it intends to close seven branch campuses, it is important to consolidate the State's nearly 500 school districts into 67 county school districts that can absorb some of the services that are now provided by the intermediate units, which can be eliminated, and establish at least one tuition-free community college in each of the 67 school districts.

The 67 school districts should be able to provide special education and the other services now provided by the intermediate units and do it even better at less cost.

With at least one tuition-free community college in each of the consolidated county school districts, it will enable future students to complete an additional two years at a four-year college or university with less debt upon graduation.

The consolidation of the nearly 500 school districts and the elimination of the intermediate units have the potential to save taxpayers a large amount of tax money and still provide students with a tuition-free community college education.

Other news from Selinsgrove, the new Street Stock class, has been added to the June 28th program which will also be running the region touring series ULMS (United Late Model Series) along with the series UEMS Modifieds and East Coast Wingless 360-sprints. # Moyer Wins First Ever Sprint Car Feature Event on Home Track

Paul Moyer of Beaver Springs won his very first sprint car feature event, and to top it off won at his home track, Selinsgrove Speedway, during the June 4th special Wednesday night show. Knowing he had a fast car after his heat race, Paul pulled the number one pill draw, setting his starting position from the pole. But finishing the job was another story, as Paul had many fast competitors behind him. He was hoping to at least finish in the top 5, but he did more than that. The car was on rails and he convincingly took home his very first sprint car win.

This is Paul's only 5th year competing in the 305 sprint car series. The Snyder county driver has been racing since 2014 but in a completely different car. He ran a 358 dirt modified competing for 4 years mainly at Big Diamond and raced previously in go-karts. So, racing on dirt wasn't a problem for Paul. Switching from a dirt modified to a sprint car was the learning curve he needed to overcome. The 2 types of racecars are like dealing with two different animals.

"The modified leans to the right in the turns and has a ton of adjustment options. The sprint car definitely leans to the left in the turns and feels so much more planted on the track. The modifieds lean on each other a lot and you really don't want to rub wheels in a sprint car," admitted Paul.

Racing blood is also in the family, as Paul went to watch his uncle Roger Moyer Sr., whose racer was also numbered the 1M and his cousin Roger Moyer, Jr. at Selinsgrove Speedway when he was younger.

Many of the 305 racers run on a very low budget as Paul depicts that scenario to a tee. Paul pulls his race car on an open trailer and many parts on the car are used. Case in point, both rear tires were bought used, as the right rear came from fellow competitor Ken Duke, Jr. (Thanks Ken!) The left rear used tire came from Doug Lucas's car #90. The wing on the car was also purchased used from local 410 racer Jake Karklin from Middleburg.

The majority of the 305 racers all have full time jobs to support their passion for racing. Paul owns Moyer Home Improvements to fund his addiction along with sponsor Urban Edge Tattoo of Selinsgrove. That is it!!!

His crew chief, Doug Lucas of Middleburg, provides his services along with Brian Thomas who helps tremendously in the shop performing maintenance on the car and supports Paul at the races when he can. Doug also recently purchased his own 305 sprint car and is a backup for Paul when needed and that car is currently being shaken down by 410 sprint car veteran Mike Walter, Sr. It was also 39 years since Doug stood in victory lane!

Another huge supporter comes from Mike Kepner, who has been instrumental putting his touches on the car set up and obviously Mike made the right call Wednesday night with the car being on rails. Seth's Racing Engines of Beaver Springs is responsible for the horsepower.

Paul was shocked that he won his first race on a huge 1/2 mile track. "I expected to win my first on a bull ring type track. I never imagined I would win on the huge track and especially my hometown track," said Paul. "To say the least, this was a huge confidence builder," said Paul. The 305 racing series can have up to 50 cars fighting for 24 spots, so just making a feature is a win in itself.

His greatest joy was found in his grandchildren.

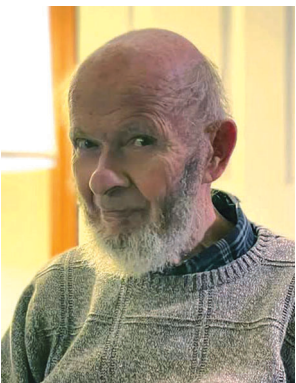

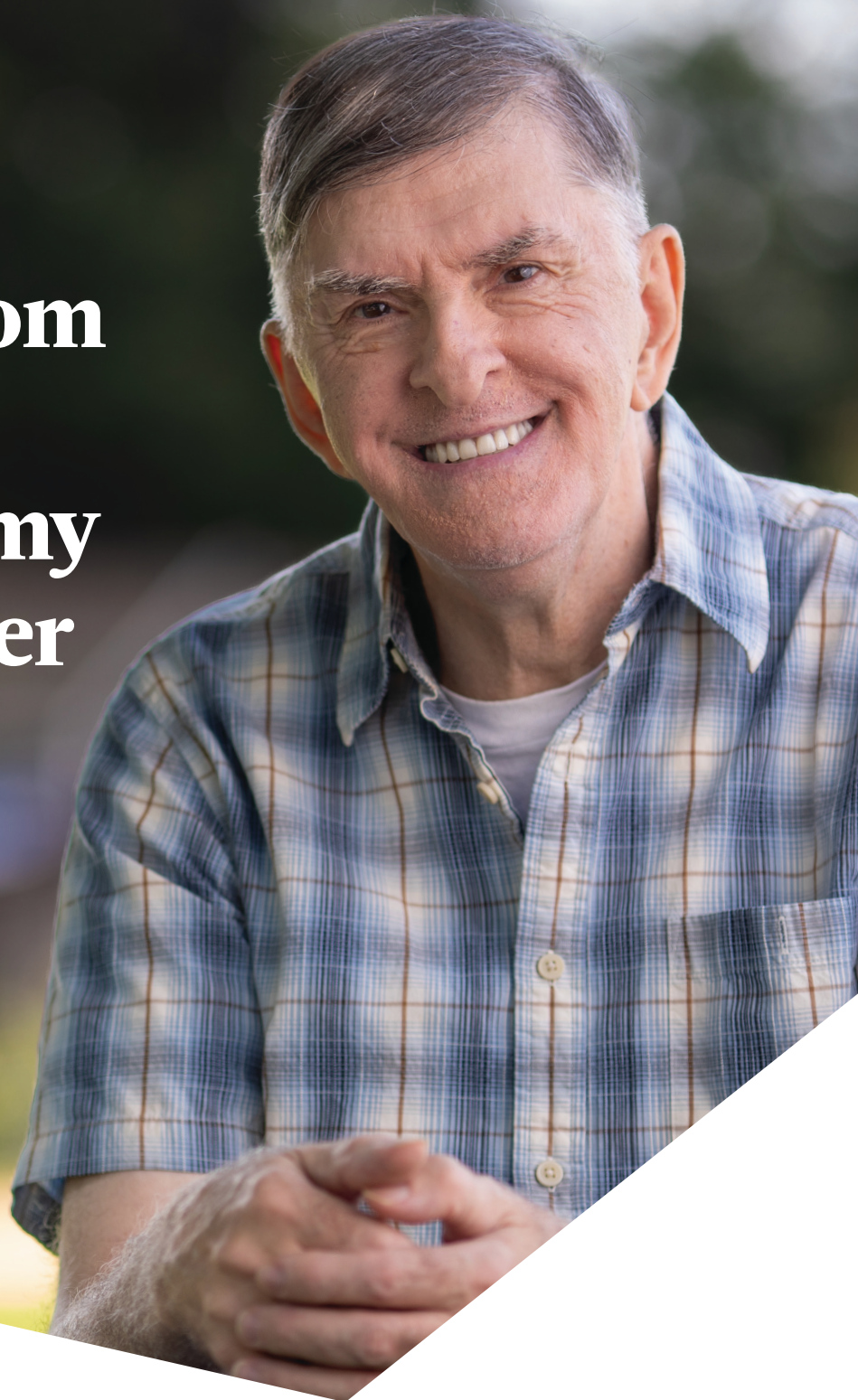

# Soles4Souls and Aunt Abby’s Shoe Mission

Soles4Souls is helping people step out of poverty one pair of shoes at a time with a mission to serve those in need, create opportunities, and protect the environment. In 2024, they distributed 5.8 million pairs of shoes to men, women, and children in need in all 50 US states and 127 countries around the globe.

Abby Yorks was recently the guest speaker at the Snyder County PASR (PA Association of School Retirees) luncheon. The members donated new and gently used shoes and learned more about the Soles4Souls mission both locally, within the United States, and globally. Members learned that all kinds of shoes are accepted including dress shoes, single shoes (for amputees), and casual shoes from youngsters to adults.

Abby explained the reach of the Soles4Souls mission by providing shoes to homeless school-age children or those struggling with poverty, providing help in times of worldwide disasters and relief during national floods, hurricanes, and tornadoes. Many shoes go to orphanages around the world, especially in war-torn areas. The shoe donations can help to restore dignity.

Another important aspect of the Soles4Souls program is to provide opportunity. Shoe donations are distributed to various programs around the world to help those in need by providing relief or to help create jobs through the selling of shoes in developing countries. Sole Soles4Souls partners with a Micro Enterprise. Micro Enterprise provides the shoes to underprivileged women who then offer the shoes for sale in the market, which in turn provides them with money to make a living for them and their families.

The program exists in 57 countries to help mostly women in extreme poverty (earning less than \$2/day). “We provide them the quality inventory of shoes to start small businesses of selling the shoes to earn money to send their children to school, feed their families, and secure a future for themselves,” explained Abby.

Abby is passionate about both the mission and the far-reaching effects of this program. She has been volunteering with Sole Soles4Souls for 16 years. She said, “What started as a small group collecting shoes for 1 month and shipping to Soles4Souls has blossomed into being an ambassador for Soles4Souls, becoming the Central Pennsylvania drop off location, and even starting my own shoe mission (Aunt Abby’s Shoe Mission) locally.”

According to Abby, “When I visited Soles4Souls headquarters in Nashville in 2022, I saw a plaque on the wall of a lady who had collected over 100,000 pairs of shoes and I thought, ‘That’s my goal!’ In the fall of 2024, we processed our 100,000 pairs of shoes for Soles4Souls. A huge milestone for everyone. Now, the goal is to reach 500,000 which sounds like a very big number when you think it’s half a million!”

Abby recently traveled with Soles4Souls to Honduras to witness the micro-enterprise program first hand. “Our in-country partner, World Compass Foundation, not only has a thrift store that hires many workers but they also train and support others who want to sell shoes on their own. Any new shoes donated stay here to be part of the local mission.”

No community is immune to poverty. Anyone can need help at any time. In 2024, Aunt Abby’s Shoe Mission was able to secure enough new shoes in stock to offer help to those in need locally. “We have worked with shelters, foster care, schools, fire victims, food pantries, etc. to get our neighbors the shoes they need.” Abby has a stockpile of shoes to help Central PA residents sorted by size. Monetary donations help to supplement what they need and what she doesn’t have in stock.

In April, Soles4Souls contacted Abby stating that they were in need of used shoes and they were sending a tractor trailer the end of May for whatever Abby could give them. “They usually send a truck when we have 20,000 pairs. I knew we would have about 15,000 come May, due to some larger donations coming in from schools. Several schools had decided to make collecting shoes a service project for their students. My volunteers and I decided we would put a push on and try our very best to get as close to 20,000 before the truck comes.”

They nearly made their goal, coming up just a little short by collecting 16,396. “This is a huge win for S4S and all the micro enterprise entrepreneurs around the world!” noted Abby.

Currently, there are approximately 70 boxes in 6 different counties including Snyder, Union, Northumberland, Montour, Mifflin, and Juniata. Collection boxes are easy ways to participate in this project. Many churches also participate in the mission as well. Abby is always looking for public, indoor places to put a box.

In Snyder County, shoe collection boxes are located at the MAC YMCA (Beaver Springs).

In Union County, shoe collection boxes are placed at West End Library, Trutts Pharmacy (Mifflinburg), Mifflinburg Muscle & Fitness, and Inspire Wellness Studio (Mifflinburg).

I work a full-time job so I am grateful that I have numerous volunteers that help in many ways.” Volunteers help to collect shoe boxes, count shoes, pack shoes, and deliver shoes locally to those in need. Volunteers also attend events to promote the mission.

The Selinsgrove Commons was a hub of environmental awareness and family fun as the Susquehanna Valley Chapters of the Citizen's Climate Lobby and Climate Reality Projecthosted their annual Joy to the Earth celebration in honor of Earth Day. Despite a few showers, the sunshine prevailed inthe afternoon making a notable difference to thisunusually windy event when held at a

different location in past years. Numerous environmentally focused organizations and vendors set up throughout the Commons, eager to share information and inspire community members to make some small changes in their own daily habits and routines to embrace a greener future.

I strolled through the eventand found the various displays informative, each offering unique insights into ways to reduce our environmental impact, nurture our local ecosystems, and contribute to a healthier Earth. The Citizens' Climate Education of Susquehanna Valley had impactful displays on the down-side of fast fashion and textile waste in this country as well as a trash graveyard displaying the tremendous amount of time it takes for various items used by many of us in our daily lives to break down in a landfill. It truly makes you think twice about the disposables we regularly use. Consider making a change in your life to include reusable containers and cups instead of disposables.

There was a booth which emphasized the importance of planting native wild-flowers to help bees and butterflies in our area. There was also a solar vendor, 4 Seasons Energy Solutions, to answer any questions people had about adding solar energy to their home or business. The Bloomsburg Children's Museum had a turtle who reached his neck up to greet me on my visit, and in fact, this weekend I had numerous unique turtle encounters if you can believe it.

Summit Early Learning had a fun activity where children could create their own nature themed picture frame to take home from the event. Even though I am only a child at heart these days, I made myself one to take home as a memory of the event as well. They also had natural peppermint bar soaps made and generously donated by Pompeii Street Soap Company in Mifflinburg. The Susquehanna University Sustainability Club offered a few children's activities as well, and children could also plant a seed to take home at a different station.

One of my usual favorites, Seven Mountains Audubon, had supplies to make your own birdcall, and the Sierra Club members shared interesting information onplastics in the environment and how many nests these days contain some plastic materials or stuffing from products used by humans.

Penn State Master Gardeners were spreading the word about the invasive Spotted Lanternfly and gave guests cards to help scrape egg masses if you find any in your own yard along with tips to destroy the eggs.

The Susquehanna Greenway Partnership works to improve access to outdoor recreation along the Susquehanna River and helps to get new trails built. They provided me with a pamphlet to help me locate trails to walk or hike on near waterways in the area. Living near the Susquehanna River provides vast opportunities to exploreareas with the benefit of beautiful water views. Some of my local favorites include the Shikellamy Marina State Park, the Isle of Que, and the Trail of Trees.

The Joy to the Earth event provided a platform for education, connection, and hands-on learning, and helped to empowerindividuals, both young and old, to take meaningful steps towards a more sustainable future right here in our community. There were so many positive things attendees could take away from a visit to the Joy to the Earth event, and some simple things you can do to help the environment are to reduce, reuse, and recycle.

# Annie Knight Gregory’s Grave Marker Restored by Conrad Weiser DAR

Recently, Conrad Weiser DAR replaced a repaired grave marker, cleaned the stone, and placed a wreath of remembrance on “Real Daughter” Annie Knight Gregory’s grave in Union Cemetery in Selinsgrove.

Annie Knight Gregory was the last surviving NSDAR Real Daughter. The daughter of Revolutionary War Soldier Richard Knight. He served as a drummer boy in the Revolutionary War with George Washington. Richard Knight was a Captain of the infantry company he organized during the War of 1812.

She was on March 23, 1843 born in Liverpool, PA when her father was 66 years old. She attended Freeburg Academy. At the age of 18, she married Benjamin Gregory, a Selinsgrove banker.

Annie Knight Gregory joined DAR on November 4, 1897 #21323. She remembered her father as a tall man of dignified military bearing. On the occasion of Annie’s 100th birthday she received greetings from President Franklin D Roosevelt. At Annie’s death on December 17, 1943, she was NSDAR’s last surviving real daughter.

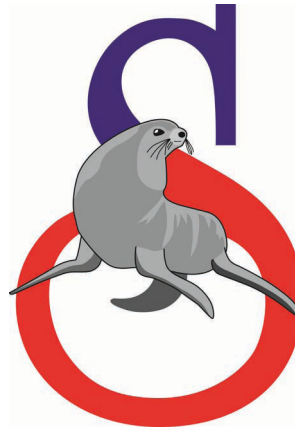

# Susquehanna Joins College Cost Transparency Initiative

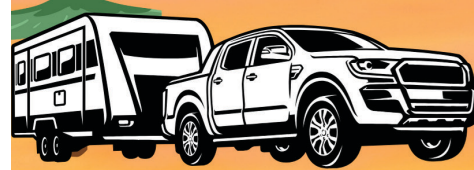

Hosted by the Lewisburg Arts Council, this eventonce again drew a multitude of art enthusiasts, both local and from afar, eager to explore the diverse offerings of over one hundred talented vendors who lined Market Street and the parking lots surrounding Hufnagle Park.

As I meandered down Market Street my senses were immediately drawn to the artistry of a different kind – the culinary arts. My journey began with a stop at Carmella’s Italian Bakery where I purchased a Napoleon, a piece of tiramisu, and a soft cannoli-filled and topped donut which surely gave my diet a setback. It seems my artistic appreciation often takes a few delicious detours in search of edible masterpieces.

The showcase of artistic talent that the festival brought is unmatched in our area, and the number and variety of handcrafted treasures on display was tremendous. I saw skillfully crafted furniture and wooden ducks, creative dog figurines, beautiful jewelry created with a variety of materials and stones, exquisite paintings, prints of amazing digital photographs, glass art, wooden bowls, ceramics, tie-dyed and children’s clothing, and watercolor stickers. I loved the beautiful fluid abstract artwork from The Artsy Amateur, and I also made a usual stop at the Lewisburg Garden Club’s stand where I purchased myself a newgraptophyllum pictum plant because I definitely deserved it, at least that’s what I told my husband.

One of my favorite stops along my festival travels was at the booth for the Handmade Parade. If you read my article from the Polar Plunge, you will recall my love for the creativity and opportunity for individual expression which the Handmade Parade brought. I spoke with Lewisburg Arts Council members, Rachel Martine and Ellen Flacker-Darer, of Lewisburg, who were busy crafting “papa bear” which would be between 9-12 feet and was a sequel to the hot pink polar bear seen at the Polar Plunge. They told me about the monthly public workshops which will help to create the memorable displays of talented artwork which will be displayed at the Polar Plunge event. They were very thankful to the local Fairfield Inn who donated bedding which was cleaned and dyed to create over 306 fabric squares being used at the Arts Festival. Attendees can spend some time in their booth to add their own personalized touch to a largerriver-themed display

which will be sewn together and displayed at next year’s Polar Plunge event.

I also spoke with Selinda Kennedy who was a featured artist of the festival. Her terracotta clay redware pottery-creations were impressive, and she even had some Lewisburg, Pennsylvania specific historic-inspired folk artwork which blends traditional techniques with her contemporary style. If you missed her work at the festival, you can check it out at the new Cooperative Gallery located at 229 Market Street in Lewisburg.

The festival catered to all ages, offering a variety of things for the kids as well which included lots of crafts and balloon art beyond browsing the vendor stalls. There were also many opportunities to savor the flavors of the region, with a wide range of delectable treats and usual fair foods, like fresh cut fries, cheesesteaks, roasted sweet corn, and cotton candy. Whether you were craving ethnic favorites, like gyros, or my favorite, the incredible Italian pastries from Carmella’s, there was truly something for everyone.

The sounds of talented local musicians were also very present. While strolling through the festival, I even heard one booth playing a violin version of a favorite song of mine, The Sound of Silence by Disturbed which was awesome! Also, a kind gentleman stopped me on my walk to the festival to tell me about a jazz band performance that would be taking place in a church slightly off of Market Street. I told him I would come back for it, and I am so glad that I did. The performance was given by Susquehanna University’s Jazz Ensemble, and the music was invigorating and uplifting with its strong sound from several brass instruments. It fondly reminded me of the many jazz concerts of my older siblings that I attended as a kid but much better. The young lady who sang along to some songs was pretty impressive as well.

The Lewisburg Arts Festival was once again rich in artistic spirit, and whether you were drawn by the allure of fine art, the temptation of delicious treats, the joy of live music, or the simple pleasure of a community gathering, the festival offered something to resonate with every visitor. 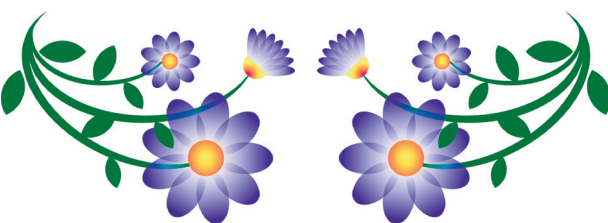
