Approximately 35 magistrate and county officials, members of the Middleburg Police Department, PennDOT, Middleburg Borough and Council, and family members gathered for the unveiling of the Tony M Jordan Memorial Highway sign. The dedication was held on September 22, 2022, at the Charles Park pavilion prior to the signs being installed. One sign is placed at the intersection of Rt. 522 and Rt. 104 and the other sign is placed on Rt. 104 at the Borough line near Shade Mountain Golf Course.

Middleburg Mayor Heidi Potter opened the dedication, saying, "Chief Tony Jordan's contribution to the law enforcement efforts in Snyder

County and beyond is extensive and unique. Few others have demonstrated his level of commitment. He was willing to invest in the future by mentoring and training the next generation. These are the one here today who now carry the baton and lead the way in those same efforts."

Then Potter noted, "It is fitting that Rt. 104 be named in his honor and memory and that our community be reminded of his life and contribution every time they read this sign."

Rep. David Rowe (R-85) was instrumental in renaming this section of roadway "Chief of Police, Tony M. Jordan Memorial Highway" a reality. His efforts as well as those of Senator John Gordner (R-27) are so appreciated. Rep. Rowe commented on Tony Jordan's remarkable and meaningful impact on the community as a whole. He noted that Chief Jordan had so many accomplishments that will leave a lasting impact on the community.

"Having role models that we can all aspire and look up to is more important now than ever before. By renaming this portion of Route 104 in his honor, we will be memorializing Chief Jordan and all his accomplishments in perpetuity so that future generations will always remember this great man and his legacy," stated Rep. Rowe.

Then, family members gathered to unveil the sign to applause from those in attendance. At end of the dedication, an eagle soared overhead and looped around Charles Park Lake.

"Chief Jordan's exemplary service to his community will serve as a role model for future law enforcement officers and public servants. These signs will serve as a daily reminder of the high standard and expectations that his legacy leaves for us to follow," noted Middleburg Police Chief Mark Bailey.

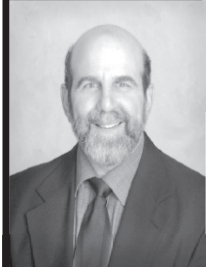

Selinsgrove Speedway To Be Under New Promotional Group

It was the “Calm before the Storm, Thunder and Lightning,” at the Selinsgrove Speedway Saturday night for the final time under the current promotional group.

Before action got under way, promoter Mike Heffner said. “Our group has decided not to renew the lease. We gave our best go at it for seven years and wish much success to whomever takes over the promoting duties.” Heffner heads up the Speedway Promotions Group that include track manager and announcer Steve Inch and local businesspeople, Todd Benner, Brian Scandle, Kathy Kurtz and Roy “Check” and Tony Adams.

Who would take over the reins at the track in the south end of Selinsgrove, that had just celebrated its 76th anniversary was answered by Selinsgrove Fairboard President, Matt Keller.

“ERS Promotional Group, is Stephanie Baker and her two sons Ethan and Reece Stutts,” he said.

“It’s going to be a huge improvement moving forward. There are a lot of big shows coming. It may take a year or two but I know they are working on things right now. They are a little behind the eight ball because its late in the year. I know she has a couple of All-Star shows scheduled but it’s tough without her having everything in place yet.”

Keller continued about the current promotional group, saying, “I have to give a hats off to those guys; they did an excellent job and I have the utmost respect for them.”

Baker, talking about her plans for the speedway said, “I think we have a pretty good idea about what we are getting into. I have friends all over the country that run race tracks so I picked up the phone and talked to them before we made the decision.

“We’d like to open with the Modifieds. In between I don’t have anything set in stone yet but we are working on some Late Model races, some Sprint Car races. Throw in the Pro Stocks, the Limited Late Models, maybe some Super Sportsman, the Wingless Sportsman. Have the 305 Sprint Cars back mostly traditional Selinsgrove divisions. I just don’t know what schedule.

“Roadrunners are going to stay on the schedule. We are not going to change any of that. We are not getting rid of any division. The fans love them we love them.”

As far as a planned night for competition Baker said, “I don’t have a plan. We are going to do what seems to fit best with everyone. I don’t want to say we are going to be a Saturday only race track. If a series or sanctioning body comes to me and that another night would work best then that’s what we are going to do.

“The staff has not been determined. I was trying to be very cautious in respect of what was going on here. I wanted the current group to finish out their season, where the attention was on their races. I’m plan on hiring a race director and good tech people so they can take care of what’s going on on the track and I can focus on what I have to do. After the season is over I’ll start speaking with people and start staffing.”

About the inner 1/5th mile Selinsgrove Raceway Park that has produced many competitors that have gone on to race and win on the larger speedway, Baker said, “The go

kart track is staying. I’m going to sit down with people from both Karts and Micros and see what everyone’s thoughts are. I don’t know a lot about those divisions so I’m going to defer to those that do but I’d like to schedule a lot more races than were on the schedule this year.

“I don’t want to say who we are talking to as far as sanctioning bodies but we are talking with a bunch of different groups and hope to make some announcements shortly.

“We will also have a streaming service. I don’t want to say anything more because I don’t have my contracts signed. I think we need to get ourselves out there so people can see how amazing the Selinsgrove Speedway really is.”

Under the current promotional team Selinsgrove has undergone some significant improvements, the most obvious was the moving of the pits to outside the fourth turn.

“You will see some more significant facility changes,” Baker said. “We are going to move race control outside of the center of the race track because those are the things we need to do to get the series we want so that tower is going to be gone but the concession stand will still be there. We haven’t received the approvals yet as to where it’s going to go.”



During the intermission, Alan Kreitzer, who was involved in the speedway during the first five years with Heffner, presented Steve Inch with a golden microphone.

“For thirty-five years, Steve has been the heart and soul of Selinsgrove Speedway,” Kreitzer said. “We can’t thank him enough for keeping the speedway operating.”

Kreitzer and Inch were then joined on stage by Inch’s wife and son and all the speedway workers.

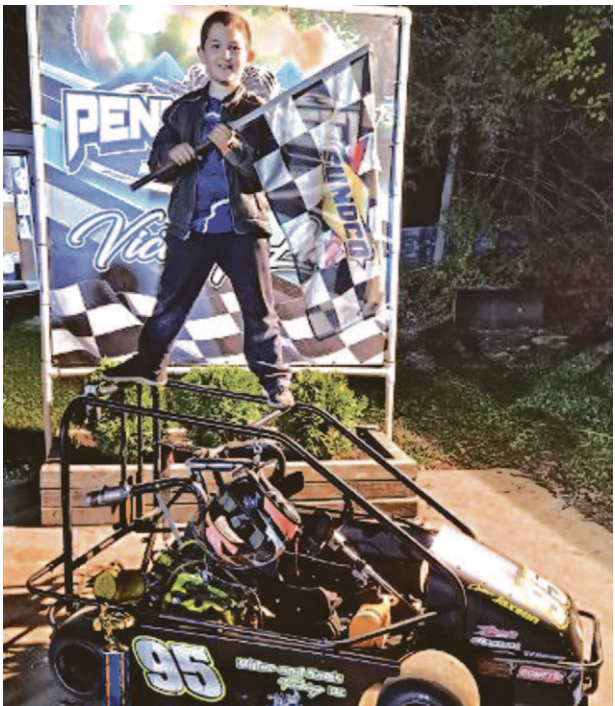

JIM NACE MEMORIAL WEEKEND HAD GOOD RACING, POINT BATTLES, TOP NAMES

The 40th running of Selinsgrove speedway National Open now titled the Jim Nace Memorial, was a two-day race this year for the second time ever the first one was in the 1991 season with Johnny Mackison Jr. scoring his only Open win. This year the Friday night part of the show had a small field of 16 drivers with all the drivers former feature winners. The started with Anthony Macri setting fast time of 15.802 close to his own record set in 2020 at 15.544 with Daryn Pittman scoring his fourth speedway win again behind the wheel of the Heffner #27, beating Brent Marks and Cory Eliason. The battle for the 410-sprint track title had Blane Heimbach of Selinsgrove leading by 130 over Lucas Wolfe who skipped the race, with Michael Walter of Middleburg back 220. Also on Friday night Bryan Bernheisel picked up his second Selinsgrove speedway super late model title the first coming in the 2018 season, scoring two wins on the season giving him eleven for his career. Dylan Yoder won the race his third of the year and 20th overall, and after missing the first race of the season come on strong at the end of the year winning the last two features placing 330 back of Bernheisel. In 13 races Yoder with three Bernheisel two along with Rick Eckert two, single wins went to Coleby Frye, Andy Haus, Jeff Rine, Gregg Satterlee, Brett Schadel, and Jim Yoder. Andrew Yoder placed second in the limited late model feature to win his first ever Limited late model title; Devon Hart last year's champ was second back 200 points. Andrew scored four feature wins, and has 11 career wins in this division. Trent Brenneman and Taylor Farling also scored feature wins

Saturday a field of 25 410 and 305-sprints were on hand with Gio Scelzi setting fast time at 15.341, with Anthony Macri going on to score the 40-lap feature win his third straight national open Jim Nace Memorial win, and his sixth career feature win at the track, Macri became the fourth driver to win this race three times in a row with Marynard Yingst won the first three ever held in 1993,94,95, Fred Rahmer did it in 1995,96,97, and Pat Cannon 2011,12,13. Getting back to the points Blane Heimbach came prepared with an extra sprint car on the grounds for both nights of racing, Blane placed 9th and 11th to win his first ever 410- title, Blane tied for it last season but Danny Dietrich got the title because of a tie breaker having scoring a feature win. Michael Walter who was in the hunt did not have a good Saturday having problems placing 17th in the feature after a 10th on Friday losing out on second to Devon Borden out 270 to the champ with Walter 275 back in third. Eight features were held this year with Heimbach two wins, along with Macri, single going to Brian Brown, Danny Dietrich, Daryn Pittman and Gio Scelzi. For the two nights of racing Macri had a fourth and first, Brent Marks,4 Pittman 1,3 Cory Eliason 3,9 Devon Borden 5,6 and Brian Brown 6,12.

The 305-sprints point battle was also going down the wire with Ken Duke of Selinsgrove holding 135-point lead over Garrett Bard, Duke placed 9th in the feature with Bard slipping back to 11th Duke earned the title by 155 over Bard. Bard led the way with three feature wins Duke and Logan Spahr two with Kenny Heffner, Domenic Melair and Austin Reed one win each. Already clinching title were Nathan Romig in the Roadrunner class by 30 over Keith Bissinger. Jake Jones was third and led the way with seven features, Levi Vial had three wins with Bob Bussey, Brad Mitch and Bissinger one win each. Jason Shultz was the 360-sprint champ by 180 over Derek Locke, only four races were run with Shultz getting three wins and Mark Smith one.

This weekend the third member of the Yoder nation Jim Yoder the father of Dylan can clinch the limited late model track title at Clinton County speedway on Friday night Jim has a 80-point led going into the points night of racing at Clinton, Matt Cochran is second with Jeremy Ohl another 110 back in third spot. Ohl has two feature wins there this season with single wins going to Jim Yoder, Matt Cochran, Andrew Yoder, and Coleby Frye. 270-micro title is also on the line with Timmy Bittner leading Jeff Weaver by 160-points. Titles have already been won by Brandon Moser Pro-Stocks his second in a row, Ryan Kissinger 305-sprints, Trevor Teats 600-micros, Coty Maines Four-Cylinders.

This weekend is the two-day WOO sprints national Open at Williams Grove, with the Friday night show winning \$10,000 and the Saturday night winner getting \$75,000. For the 60th running of this event. Last year California driver Carson Mace-do scored the 40-lap feature win over Logan Schuchart, and Sheldon Haudenschild. On Tuesday Oct 4th Lincoln speedway will run the Brian Monteith Tribute race paying \$7,000 to win for the 410-sprints. This race is sandwiched in between the WOO show at Williams Grove and the one at Port Royal on October 7th and 8th.

Stephanie Baker is taking over promoting Selinsgrove Speedway for the 2023 season. More details should be announced soon.

Macri Three-Peats In Selinsgrove Nace Memorial National Open

Anthony Macri of Dillsburg captured his third straight victory in the Jim Nace Memorial 40th Annual National Open for 410 sprint cars Saturday night at Selinsgrove Speedway.

Macri, who won the division's first race of the year in April's Ray Tilley Classic, book-ended his season at the historic speedway by becoming the fourth driver to record three consecutive wins in the National Open. The late Marynard Yingst of Linglestown (1983-85), Fred Rahmer of Salfordville (1995-97), and Pat Cannon of Eters (2011-2013) also pulled off the feat.

The win aboard the Macri Concrete/J&S Classics No. 39M was worth \$26,000, a tribute to one of Nace's most popular car numbers he campaigned in central Pennsylvania sprint car racing.

Gio Scelzi of Fresno, Calif., was the Fast Tees Fast Qualifier with a lap of 16.341. Scelzi scored his first career win at the track in May.

Blane Heimbach of Selinsgrove, who won two of the eight 410 sprint car races this year, clinched his first career Lelands.com 410 sprint car track championship worth \$5,000.

Logan Spahr of Lewisberry won his second race of the year in the 20-lap PASS 305 sprint car feature.

Ken Duke of Selinsgrove wrapped up his first career Apache Tree Service 305 sprint car track championship.

The two-day National Open weekend, a first at the track since 1992, concluded the speedway's 76th anniversary season.

Polesitter Danny Dietrich out-dued second-place starter Anthony Macri for the early lead at the start of the sprint car main event. For the first laps, Macri tormented Dietrich for the front spot but struggled to find a way around him. On the seventh circuit, Macri powered underneath Dietrich in turn two to take command of the field while third-place starter Brian Brown and fourth-place starter Freddie Rahmer raced in the top five.

At the lap 15 mark, Dietrich reeled in Macri again and on lap 17 pulled a slider in turn two. Dietrich was able to take the lead back

for a few seconds until Macri raced back underneath him to reclaim the front spot out of turn two.

The race was red-flagged on lap 20 for a scheduled fuel stop. Under the red flag, Brown's car developed a flat tire and he was forced to restart on the rear of the field.

When the race resumed, Macri led Dietrich, 10th-place starter Brent Marks, sixth-place starter Daryn Pittman, and Rahmer. The closest battle on the track in the second half of the race was the battle for third between Marks and Pittman.

In the final laps of the race, Dietrich was reeling in Macri, erasing the deficit with each passing lap. At the checkered flag, Macri was victorious by just 1.6 seconds over Dietrich, Pittman, Marks, and Rahmer.

Front row starter Kruz Kepner pulled into the early lead at the start of the 305 sprint car feature and was chased by third-place starter Austin Reed.

Reed took over the front spot on lap three with an outside pass in turn four. He set the pace through lap seven when sixth-place starter Logan Spahr made the winning pass using the inside lane off turn four.

Kepner attempted to reel in the leader to no avail. Spahr took the checkered flag by two seconds over Kepner, Zach Rhodes, Reed, and Doug Dodson.

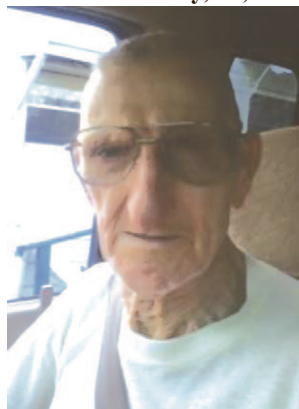

In his spare time he enjoyed his sweets and eating ice cream, he loved going for rides in the mountain and sitting on his porch with his dog Zara.

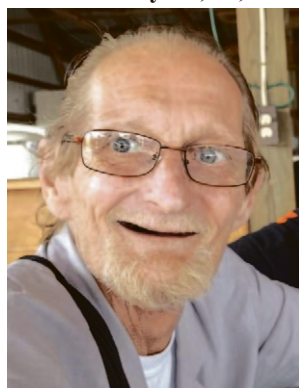

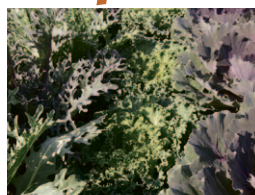

Conservation District Offers Farmers Help Writing Plans

Any Snyder County farmer, within the Middle Creek Watershed, interested in having necessary plans to follow PA Department of Environmental Protection (DEP) regulations can sign up at the Snyder County Conservation District (SCCD). The Conservation District will connect you with a commercial plan writer to develop a manure management plan (MMP) and/or agricultural erosion & sedimentation (Ag. E&S) plan.

[Only operations within the Middle Creek Watershed who are not concentrated animal operations (CAOs) or concentrated animal feeding operations (CAFOs) are eligible for this specific program.]

The pressure is on farmers to comply with new agricultural environmental regulations enforced by DEP and the US Environmental Protection Agency (EPA). This will also help farmers thinking of seeking financial assistance from various programs through the SCCD to install conservation practices on their operations.

Interested farmers must complete an application with the Conservation District. Additional information is available at the office at 10541 Route 522, Middleburg. Contact Barry Spangler, Agricultural Conservation Technician at 570-837-3000, extension 5, for more information. Office hours are Monday through Friday between 8:00 a.m. and 4:00 p.m.

General Election Is November 8

Tuesday, November 8 is the General Election. Voters will have the opportunity to elect Pennsylvania's next governor and lieutenant governor, members of the U.S. House and Senate, and state House and state Senate (in even numbered senatorial districts). Voters can visit their polling precinct in person on Election Day from 7 am- 8 pm. The General Election is being held on November 8. The last day to Register to vote in the General Election is October 24.

Completing a Mail-In or Absentee Ballot is another option available to voters. The Snyder County Elections Office, located at 9 W. Market Street in Middleburg, is currently accepting completed Mail-In and Absentee Ballots. The last day to apply for a mail-in or civilian absentee ballot is November 1.

Applications are available at the Elections Office at the Snyder County Court House or online at vote.pa.gov. If a voter provides an email address on the form, they will receive a confirmation email that their application has been processed and another confirmation email when the ballot is being processed.

If on a previous Mail-In Ballot application, a voter checked the "Annual Mail-In Request" section (Section 7), he/she will automatically receive their ballot for General Election in the mail.

Follow All Steps

To ensure that your ballot is counted, follow all the steps. Fill in the oval beside the candidate or the write-in name. When completed place the ballot in the privacy envelope. Then put the privacy envelope inside of the exterior envelope. The final step is crucial, sign the external envelope. Fill out the requested information including the current date. Print your name on the designated line.

Completed ballots may be sent using the United States Postal Service or by submitting it directly to the Snyder County Elections Office. For those not wanting to enter the building, a service bell is located outside building and an

official from the Elections Office will come to the door to receive the ballot. There are no drop-off boxes in Snyder County.

If dropping off a ballot, each voter MUST hand-deliver his/her own ballot. Voters may NOT deliver a ballot for another person. Ballots are currently being accepted.

All ballots must be received by the County Board of Elections by 8 pm on Election Day.

In-Person Voting

The polls are open from 7 am- 8 pm for the General Election on November 8.

Dates to Remember

October 24- Last day to register to vote for the General Election.

November 1- Last day to apply for a Mail-in or Absentee Ballot.

November 8- General Election Day in Pennsylvania.

Seeking Donations for Bibles in Creole to Teach Teenagers in Haiti

Dr. Wayne Hassinger graduated from Middleburg High School as the Valedictorian. He received a scholarship to attend Delaware Valley College to study Animal Science with a career goal to become a veterinarian. After 3 years in college, he was awarded a full scholarship to the University of Pennsylvania, College of Veterinary Medicine. In 4 years, he graduated with honors. He moved to New York state where he worked as a large animal veterinarian. It was there that he met his wife and was happily raising their 2 children. After about 25 years, he realized that he needed a career change. After deep research and prayer, he moved his family to Haiti to serve as missionaries. His original plan was to volunteer as a veterinarian to livestock farmers as there was a desperate need for those in Haiti. While this is still his main purpose, he also teaches farmers correct animal husbandry practices as well as animal care.

Last year, he and his wife expanded their mission to start a Bible Study for 6 teenagers once a week. They also offered them refreshments and fellowship before and/or after the Bible Study. As the Bible study continued, "brothers have brought siblings and siblings have brought friends". Within 1 year, this group of teenagers has grown so now there are "no less than 100 young people actively on weekly rosters" to study the word of God. They still meet weekly, but are divided into groups by age with meetings held 4 mornings a week.

Wayne would like to have each teenager own their own Bible in their native language of Haitian Creole. There is only one complete version of the Creole Bible and it's printed in South Korea. The exchange rate varies, but this Bible can be shipped to Haiti for about \$20. The Beavertown United Methodist Church has decided to help Wayne raise money for these Bibles. We are asking for donations so each teenager in his Bible Study group in Haiti can have their own Bible. If additional funds can be raised, they would be put towards chairs for the teenagers to use in Bible Study or for future growth of this group. Fun, Fall, Gardening Tips!

As we enter the late stages of the growing season, it might be a good time to check your property for areas in need of seed. The State has some clear rules for properties with earthmoving projects: the most basic of these rules tells us that we should seed and mulch disturbed earth that is inactive after four (4) days. Let's say you have a stockpile of soil somewhere in your yard. You might have the best intentions of spreading that soil somewhere (e.g., to fill some holes or low spots), but the reality is that we are all busy people. If there is even a chance that your stockpile might survive untouched come fall or winter, then you should go ahead and seed and mulch it now.

The rule mentioned above would apply whether your property is residential or commercial/industrial. Even if your property is not the host of a large or fancy project, it is simply good practice to stabilize areas of exposed earth when we have the chance. Obviously, fewer species will sprout and grow as we move into

fall.

Alright, so you are ready to throw some seed out in the yard. What do you try to plant? Well, as you might imagine, the recommendations are detailed and dependent on a variety of factors—slope, time of year, permanent vs. temporary, etc. If you are interested in seeing these details in their full glory, then you should refer to DCNR's publication "Pennsylvania Bureau of Forestry Planting and Seeding Guidelines" (an easy find on the web).

If you are a little short on time, then it might be a good strategy to focus on winter rye (*Secale cereale*) or annual rye (*Lolium multiflorum*). These species will grow well after August 15, and DCNR recommends their use in areas needing temporary stabilization. If used as part of a seed mix, incorporate approximately 30 lbs. of rye seed per acre; if used alone, then double this rate. Finally, if you are not sure whether to use straw or hay as a mulch, go with straw!

Staff will continue to work from existing regional offices in Bloomsburg and Sunbury.

Each Wednesday from June 15-August 3 youngsters and their parents were treated to storytelling and literacy activities.
